



Dear Mr. Stognor:

Further to our letter of September 21, 1995 Mobil Exploration & Producing U.S. Inc., (MEPUS) as Agent for Mobil Producing Texas & New Mexico Inc., respectfully requests your authorization for an amendment to the above order as follows:

589 FSL & 1909 FWL (Unit F) of
Section 33, Township 21S, Range 37E
API No. 30-025-06982**

Upon completion, because of the Gas/Oil Ratio factor, this well was designated as an oil well, so we are requesting that it be carried as an oil well in the Blinebry, with 40 acres being assigned to it, 40 acres being dedicated to the E.O. Carson #9, which is also producing, as an oil well, out of the Blinebry and the remaining 80 acres being assigned, as a non-standard gas proration unit, to the E.O. Carson #14 which is gas well producing out of the Blinebry.

The following items are being submitted in triplicate, in support of this request.






