Dear Mr. Trautman:

Reference is made to your applications dated November 21, 1994 and December 9, 1994, both of which pertain to Blinebry gas production on Chevron's Amanda fee lease in the W/2 SE/4 of Section 25, Township 22 South, Range 37 East, NMPM, Lea County, New Mexico.

It is our understanding that the Amanda Well No. 1 (API No. 30-025-10449), located 1980 feet from the South and East lines (Unit J) of said Section 25 has recently been reclassified from a Blinebry oil well to a gas well and that Chevron is proposing to recomplate the Amanda Well No. 3 (API No. 30-025-29975), located 330 feet from the South line and 1650 feet from the East line (Unit O) of said Section 25, which is currently a producing oil well in the Blinebry Oil and Gas Pool, to a gas well in said pool. It is further understood that both gas wells are to be simultaneously dedicated to the proposed 80-acre tract comprising the W/2 SE/4 of said Section 25.

By authority granted me under the provisions of Rule 2(a)4 of the Special Rules and Regulations for the Blinebry Oil and Gas Pool, as promulgated by Division Order No. R-8170, as amended, the following described 80-acre non-standard gas spacing and proration unit is hereby approved:



Also, Chevron is hereby authorized to simultaneously dedicate Blinebry gas production from the Amanda Well No. 1 with the Amanda Well No. 3. Furthermore, you are hereby permitted to produce the allowable assigned the subject GPU from both wells in any proportion.
