This well was recently recompleted from the Blinebry to the Paddock and we are simultaneously filing for a Downhole Commingling Permit to add the Blinebry formation.

As a Blinebry gas completion, the well was spaced on 160 acres. Cross Timbers drilled the #7 and 8 wells located in the NE/4 NW/4 and SW/4 NW/4, respectively, and both are producing from the Blinebry Oil & Gas (Oil) Pool. 


