January 18, 2011

NGP mails out (via certified mail) well proposals and AFEs for the Long Branch #1, Long Branch #2, Long Branch #3, and Long Branch #4 wells to unleased mineral interest owners and leasehold interest owners: COG, Concho, Joe Marion Bohannon, Fred Bohannon, Marvin J. Bohannon, Marianne Bohannon Jost, Lynette Layton Children's Trust, Mary Louise Hubbard, Brian Scott Manning, Gail McCleave, Patsy Madden Carmoney, Nearburg, Saguaro Resources, Chi Energy, Cactus Energy, E3 Energy, ABO Petroleum, Myco Industrial, Yates Drilling, Sharbro, Yates Petroleum, and Devon.

March 8, 2011

NGP engages Jim Bruce as attorney and asks him to initiate force pooling proceedings of all four Long Branch wells. Hearing is scheduled for April 14, 2011. All unleased and non-participating interests are to be force pooled.

March 15, 2011

Jim Bruce filed four compulsory pooling cases including Long Branch #2

March 18, 2011

NGP AFE's and well proposals for the Glass "7" D-A #1H Well and the Glass "7" E-H #1H Well from Nearburg.

March 23, 2011

Jim Bruce sent notice (via certified mail) to Brian Scott Manning of hearing with application an others

March 30, 2011

NGP re-sends well proposals with AFEs to unleased mineral interest owners: Paul M. Bohannon, George Bohannon, Patsy Madden Carmoney (previously returned as undeliverable), Gail McCleave (previously returned as undeliverable)

March 31, 2011

NGP sends well proposals with AFEs to unleased mineral interest owner: Fred Bohannon Royalty Co.

April 4, 2011

Jim Bruce files for a continuance of the April 14, 2011 hearing to May 26, 2011. Continuance filed in order to give time to notify previously un-located mineral interest owners.

April 11, 2011

Proposed JOA sent to Oxy and Yates Petroleum Corporation

April 14, 2011

Original Hearing date, continued until May 26, 2011.

May 18, 2011

Manning's oil & gas leased dated May 2, 2001 to DHA, L.L.C. is recorded in Eddy County

November 4, 2011

Emerald Johnson speaks via telephone with DHA, LLC employee Kahleena concerning DHA, LLC's leasehold interest in Section 7, T-19-S, R-26-E, Eddy County, New Mexico. January 18, 2011 NGP submitted an a well proposal letter and AFE, proposing the Long Branch Fee #1H, Long Branch Fee #2H, Long Branch Fee #3H, and Long Branch #4H to mineral owner, Brian Scott Manning. Subsequent to this well proposal, DHA, LLC leased Mr. Manning's mineral interest under Section 7. Kahleena states that Mr. Manning has provided said well proposal to DHA, LLC.

October 30, 2011

NGP initiates drilling operations of the Long Branch Fee #2H Well.
