June 16, 2014: Cimarex (Jordan Jenkins Cockrell) called all working interest owners to follow up and be sure that they had received the well proposal packet

June 24, 2014: Cimarex (Jordan Jenkins Cockrell) placed phone call to Irene McIsaac to discuss the McIsaac family assigning their interest to Cimarex

June 26, 2014: Cimarex (Jordan Jenkins Cockrell) mailed Assignment of Oil and Gas Lease to Irene McIsaac, Patricia McIsaac, Nancy Redford, Mary Shoener, and Daniel MacIsaac

June 26, 2014: Cimarex (Jordan Jenkins Cockrell) began placing regular calls to all working interest owners

July 30, 2014: Cimarex (Jordan Jenkins Cockrell) received MBOE, Inc.'s Election to Participate

August 5, 2014: Cimarex (Jordan Jenkins Cockrell) received HOG Partnership, LP's Election to Participate

August 6, 2014: Cimarex (Jordan Jenkins Cockrell) received Rubicon Oil & Gas II, LP's Election to Participate

August 12, 2014: Cimarex (Jordan Jenkins Cockrell) received Nortex Corporation's Election to Participate
