WPX Energy Production, LLC ("WPX"), pursuant to the provisions of Division Rule 19.15.15.13, hereby seeks administrative approval of an unorthodox end of lateral in the Chaco Unit NE HZ (Oil) (98088) pool for the *NE CHACO COM #255H*. This is a horizontal well with a surface location of 1305' FSL and 240' FWL, Section 5, T23N R6W and an end of lateral location of 325' FNL & 231' FEL, Section 8, T23N R6W. See attached plat.

Pursuant to NMOCD Order number R-13817 and R-13817A, a 9,238-acre Project Area was created as well as a new pool entitled Chaco Unit NE HZ (Oil) (98088). Under the provision of these orders, this pool shall be developed on 320-acre spacing and no portion of the completed interval shall be closer than 330 feet to the outer boundary of the Project Area.

The end of lateral for this well is located 231' from the eastern boundary of the Project Area. The bottom of the RSI tool was set at a depth of 10,808' MD, 315' FNL & 293' FEL making it unorthodox to the NW4 of Section 9, T23N, R6W and the SW4 of Section 4, T23N, R6W.

WPX owns 100% of the NW4 of Section 9, T23N, R6W. Coleman and JMJ Minerals have partial ownership in SW4 of Section 4, T23N, R6W.

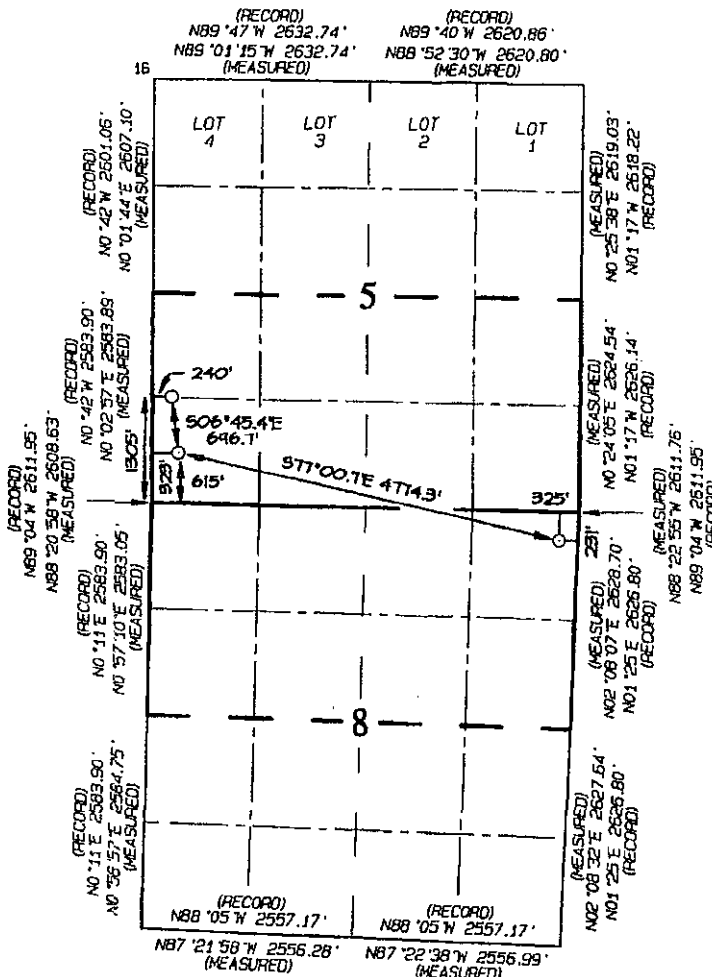

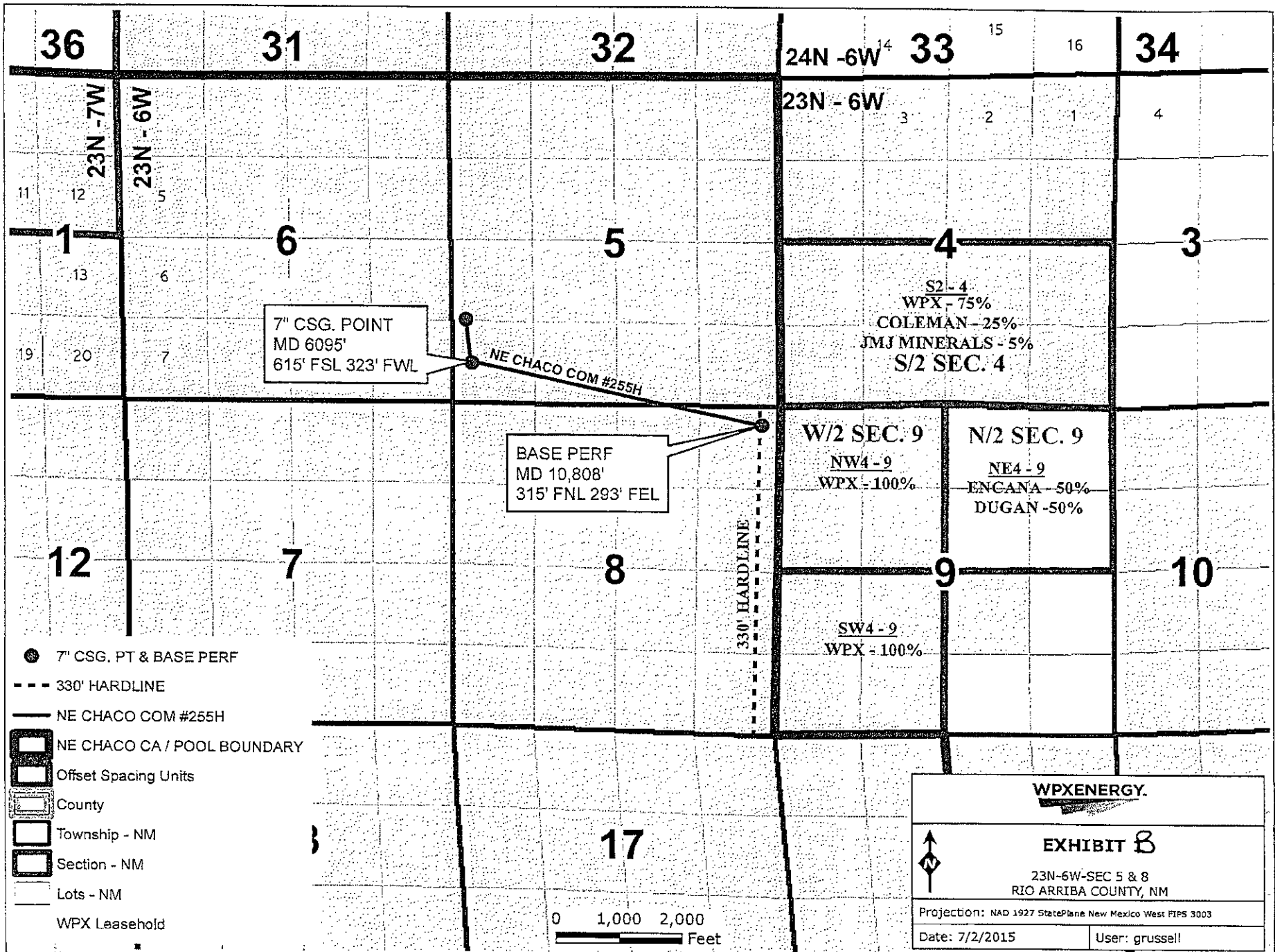
