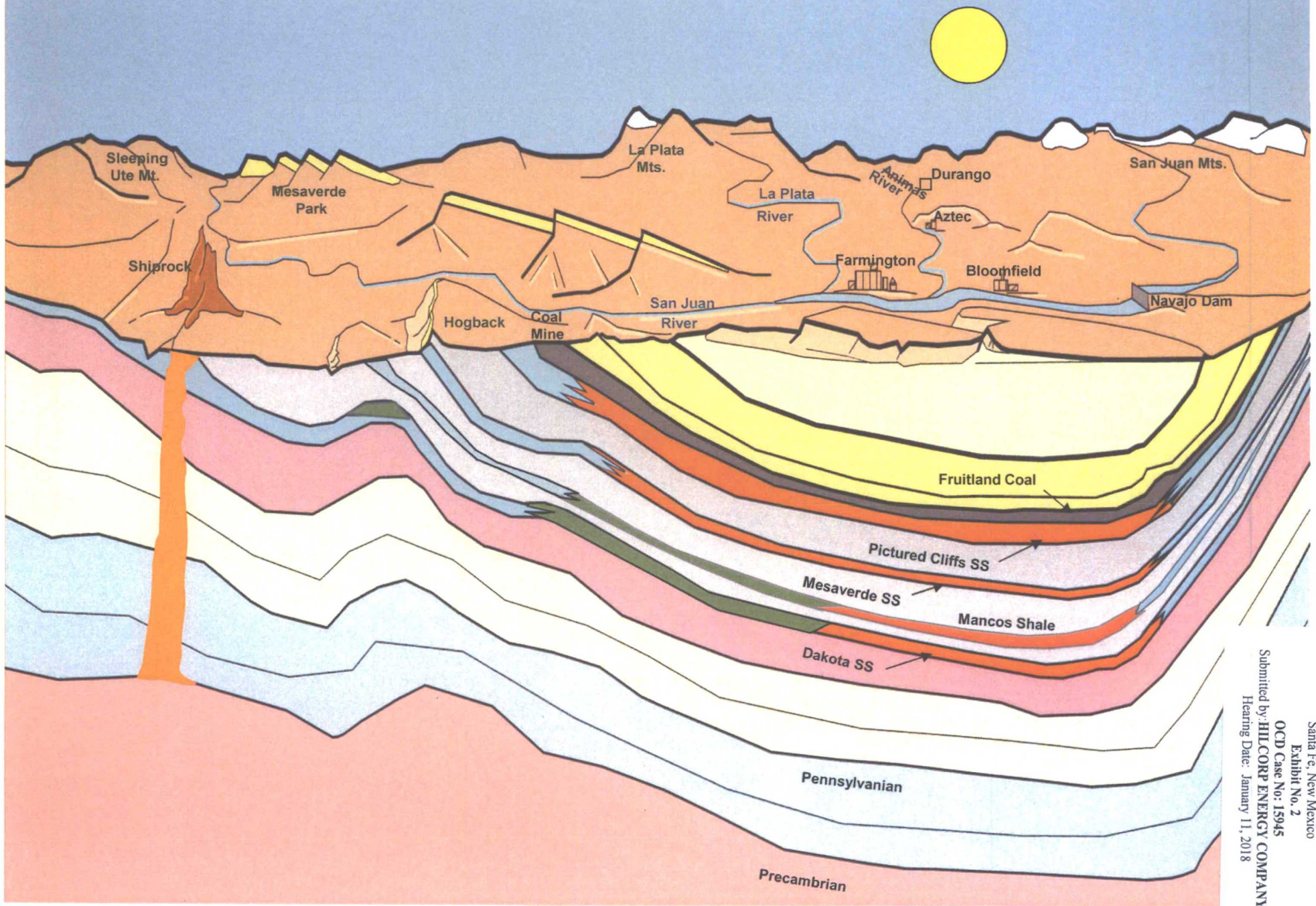

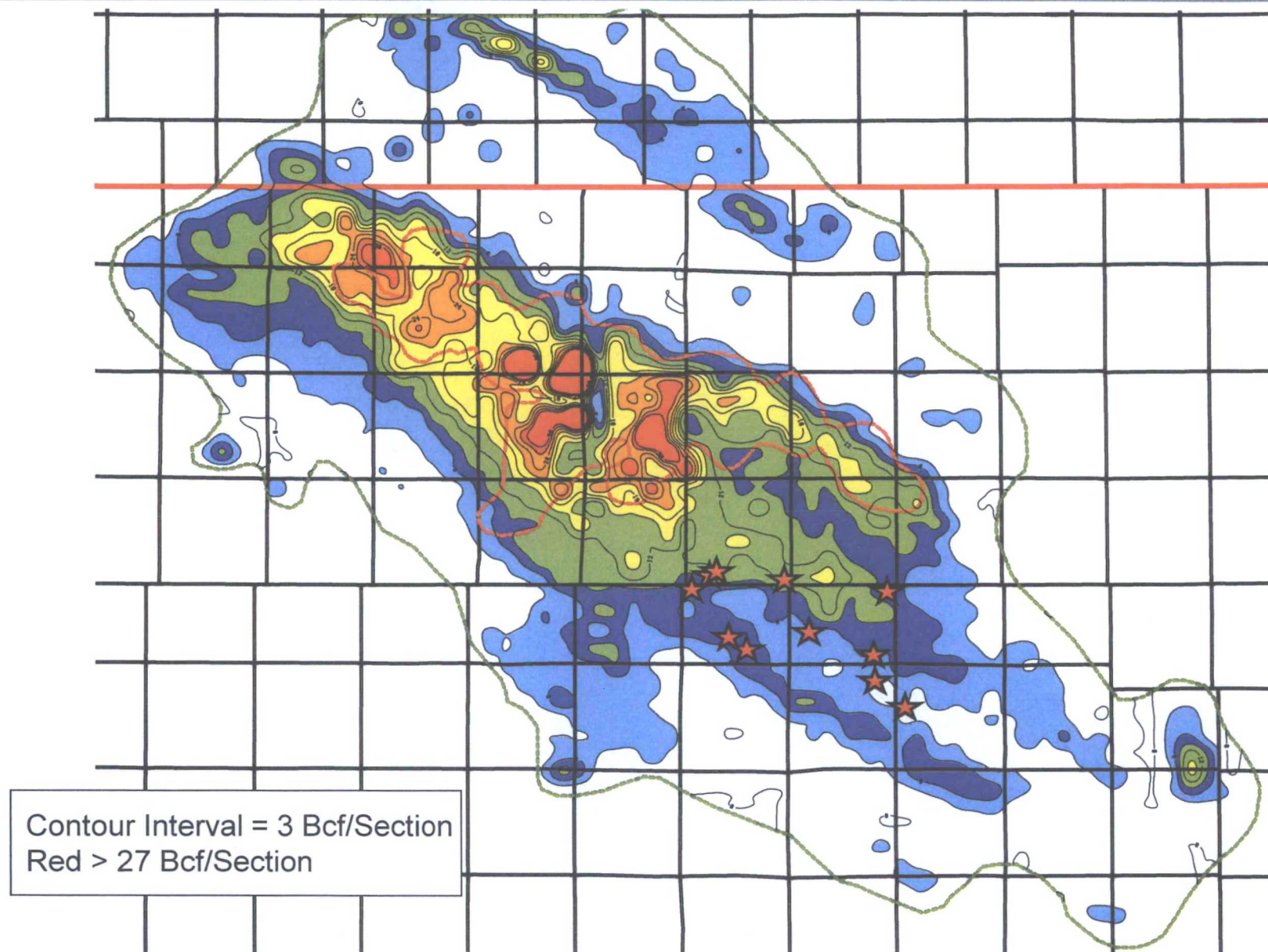


MV Original Gas-in-Place



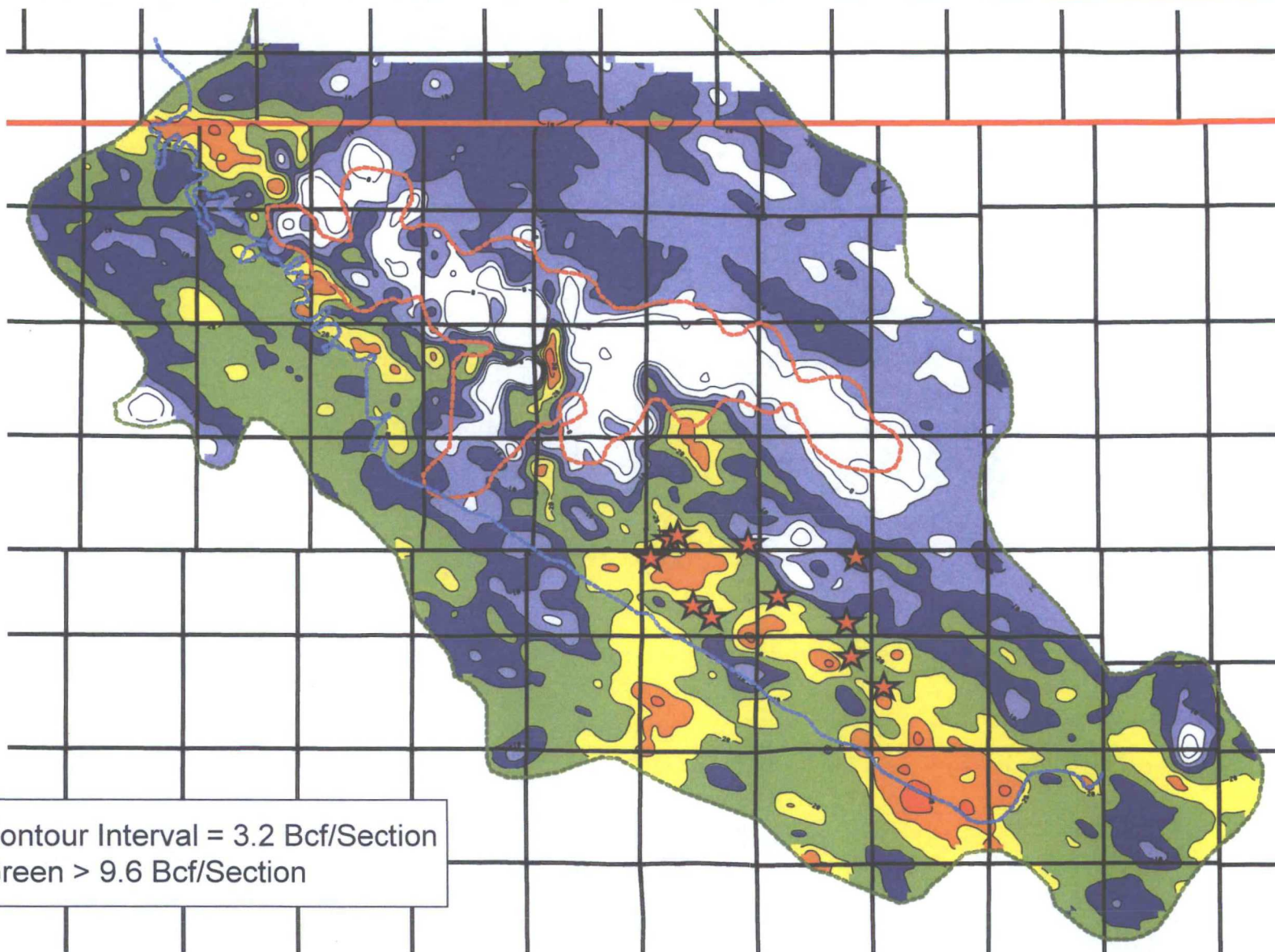


MV Cumulative Gas Production





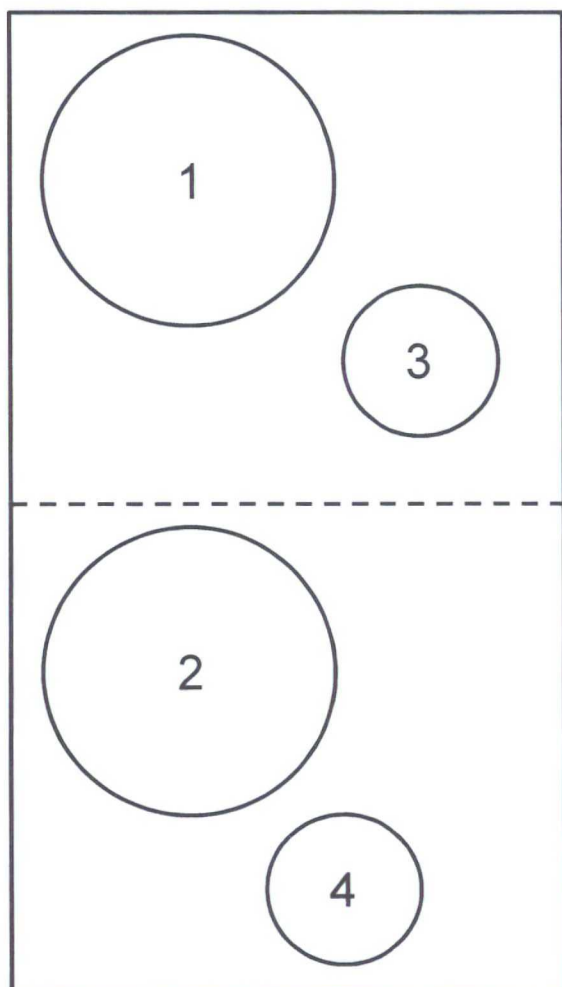

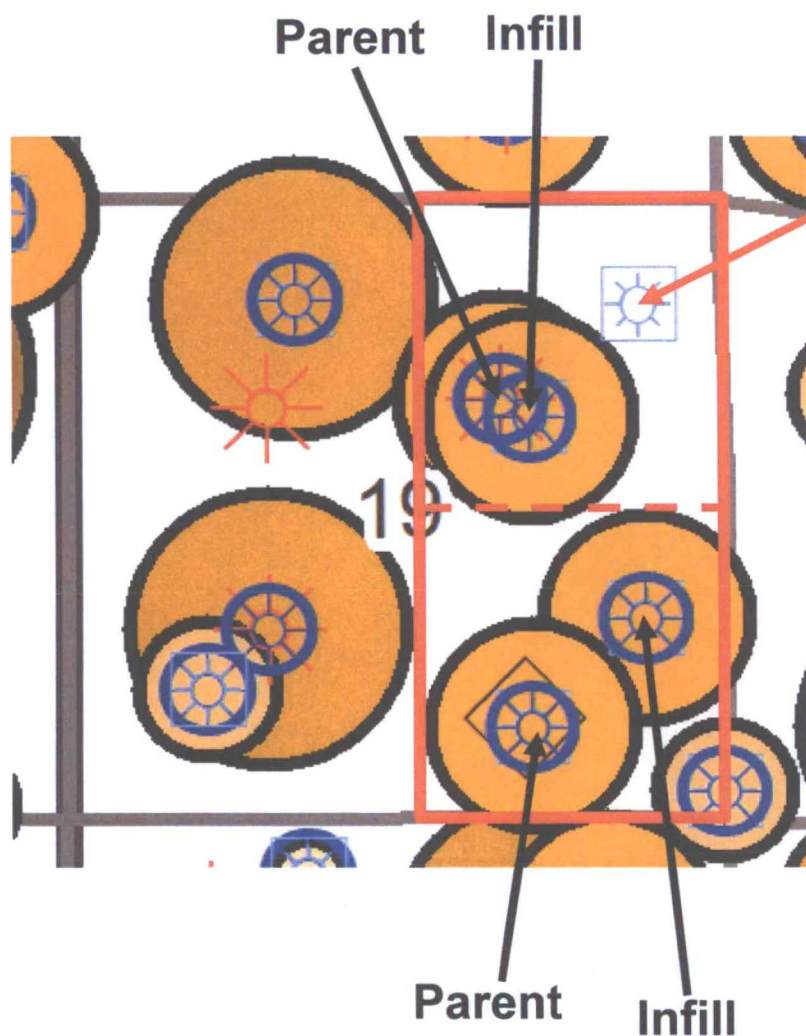

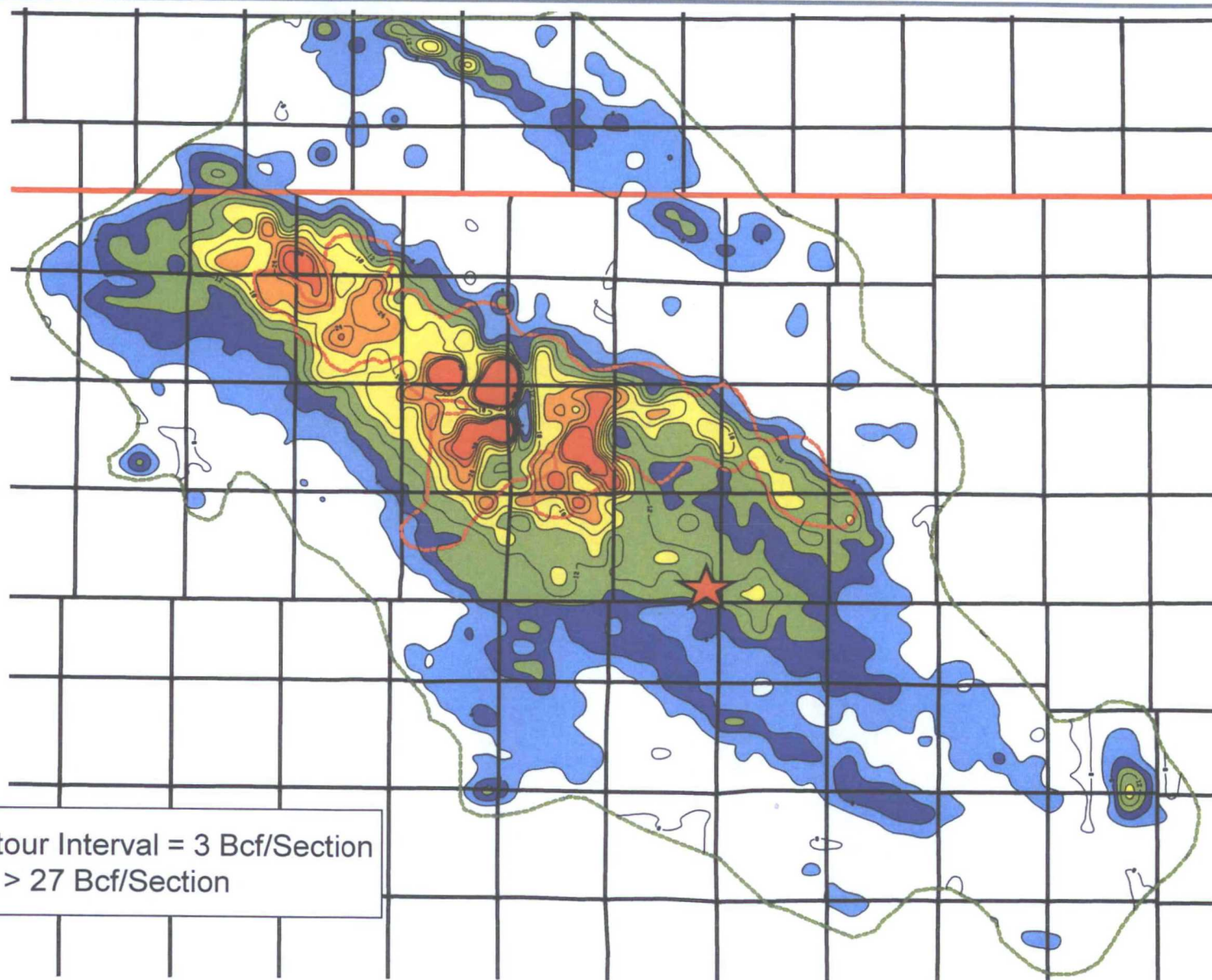


MV Original Gas-in-Place





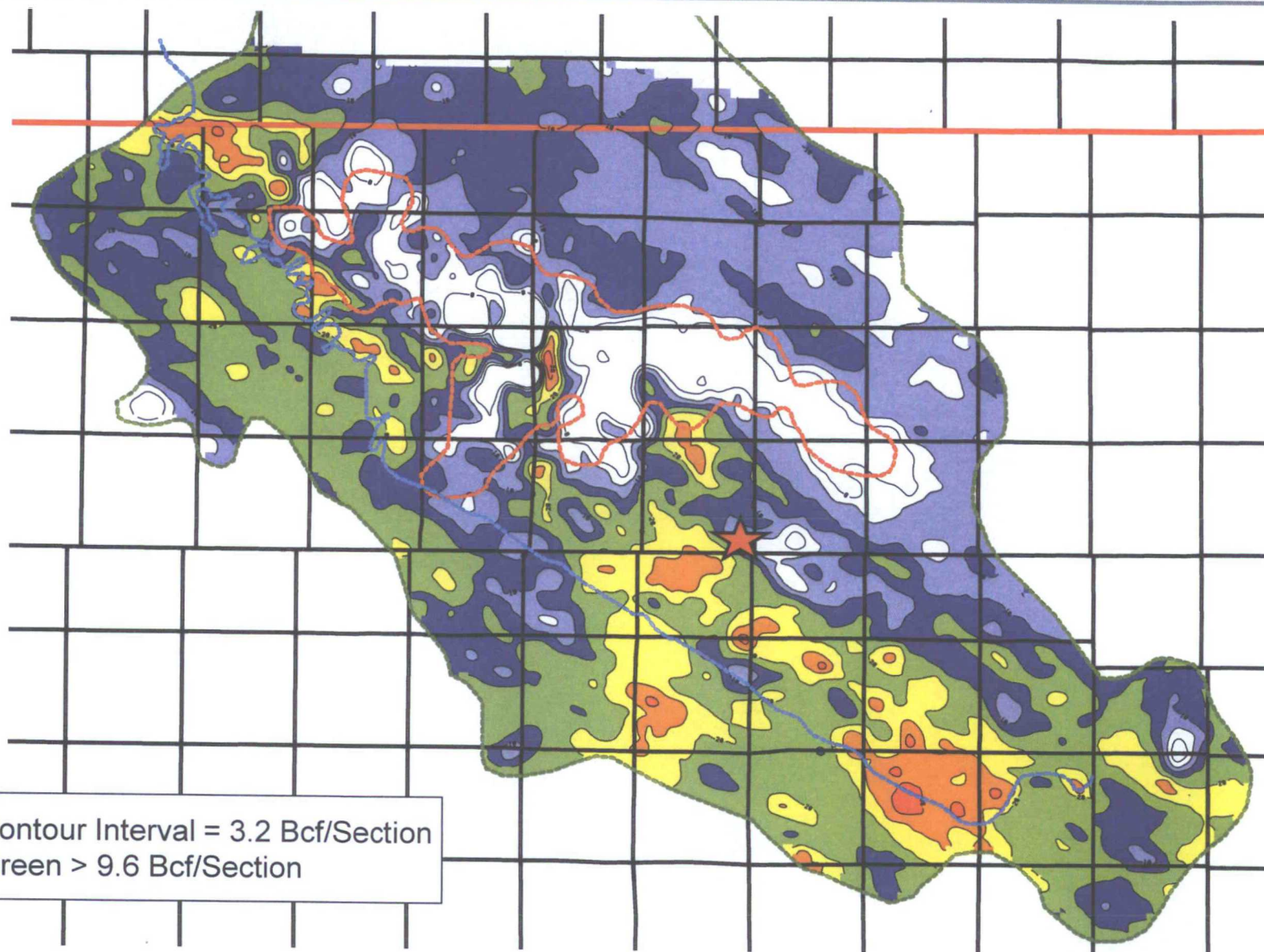
MV Cumulative Gas Production

MV Remaining Gas



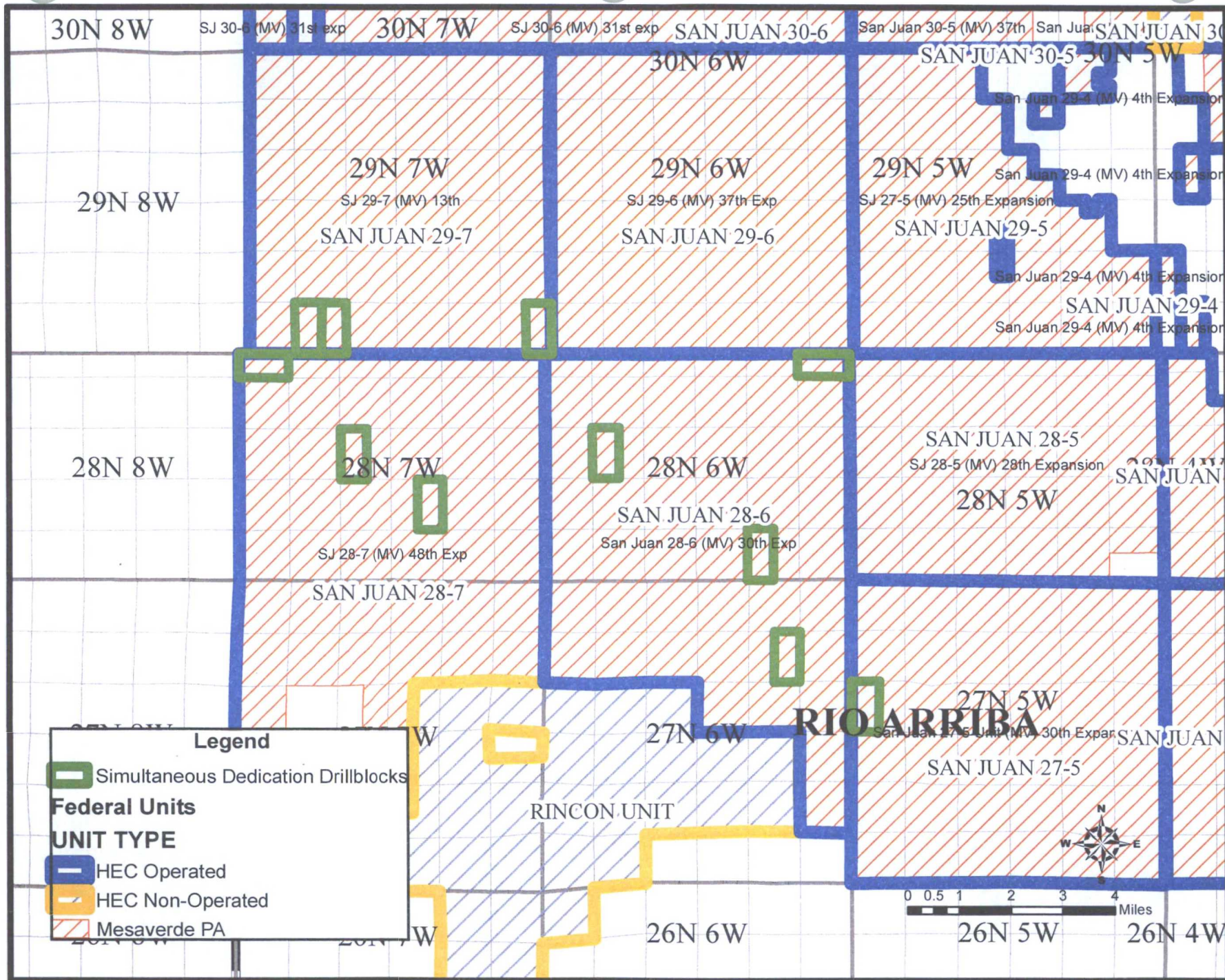

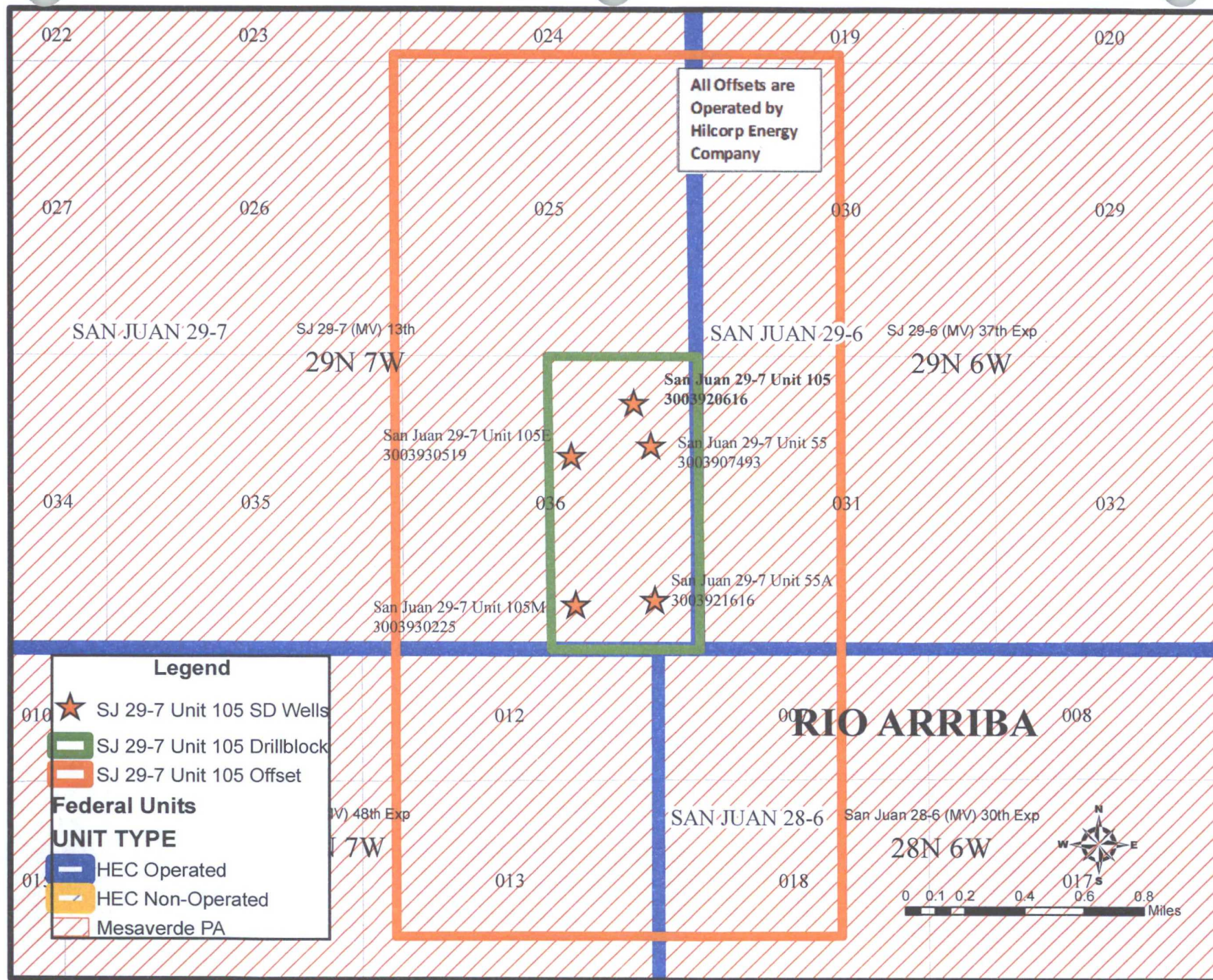
