- ALLOWABLE: (1) Consideration of the allowable production of gas for August, 1983, from fifteen prorated pools in Lea, Eddy, and Chaves Counties, New Mexico.
- (2) Consideration of the allowable production of gas for August, 1983, from four prorated pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico.

CASE 7893: (Continued from June 23, 1983, Examiner Hearing)

In the matter of the hearing called by the Oil Conservation Division on its own motion to permit Sovereign Oil Company, Allied Fidelity Insurance Company, and all other interested parties to appear and show cause why the Sovereign 32-6 Well No. 1 located in Unit E of Section 9, Township 32 North, Range 6 West, San Juan County, should not be plugged and abandoned in accordance with a Division-approved plugging program.

CASE 7912: (Continued and Readvertised)

Application of Jerome P. McHugh for compulsory pooling and an unorthodox location, San Juan County, New Mexico. Applicant, in the above-styled cause, seeks an order pooling all mineral interests in the Mesaverde formation underlying the E/2 NE/4, SW/4 NE/4, and Tract 55, Lots 5, 6, and 7 of Section 18; and the SE/4 SE/4, Lots 8 and 9 and Tract 55 of Section 7, all in Township 31 North, Range 7 West, to be dedicated to a well to be drilled at an unorthodox location 640 feet from the North line and 1250 feet from the East line of said Section 18. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of Northwest Pipeline Corporation as operator of the well and a charge for risk involved in drilling said well.

CASE 7915: Application of Estoril Producing Corp. for an unorthodox gas well location, Lea County, New Mexico. Applicant, in the above-styled cause, seeks approval of an unorthodox Atoka gas well location 660 feet from the South line and 990 feet from the East line of Section 10, Township 23 South, Range 34 East, Antelope Ridge-Atoka Gas Pool, the S/2 of said Section 10 to be dedicated to the well.

CASE 7916: Application of Southern Union Exploration Company for the amendment of the special rules governing the Bisti-Lower Gallup Oil Pool, San Juan County, New Mexico. Applicant, in the above-styled cause, seeks the amendment of Rule 2 of the special rules governing the Bisti-Lower Gallup Oil Pool as promulgated by Division Order No. R-1069-B to provide for 80-acre proration units comprising either the N/2, S/2, E/2, or W/2 of any quarter section in said pool.

CASE 7917: Application of Mobil Producing Texas & New Mexico, Inc. for a waterflood expansion, Lea County, New Mexico. Applicant, in the above-styled cause, seeks authority to expand its Langlie Mattix Humphrey Waterflood Project by injection of water through one well located 1300 feet from the South line and 1750 feet from the West line of Section 3, Township 25 South, Range 37 East.

CASE 7918: Application of Robert N. Enfield for commingling and off-lease storage, Eddy County, New Mexico. Applicant, in the above-styled cause, seeks authority to commingle production (liquids) and for the off-lease storage of same for its Douglas, Walters, and Federal Wells No. 1 in Sections 7 and 18 and a well to be drilled in the S/2 of Section 6, all in Township 19 South, Range 27 East, East Lake Field.

CASE 7919: Application of Sovereign Oil Company for amendment of Division Order No. R-7242, San Juan County, New Mexico. Applicant, in the above-styled cause, seeks an amendment of Division Order No. R-7242 to show corrected unorthodox surface and bottomhole locations for their 32-6 Well No. 1 located in Section 9, Township 32 North, Range 6 West, as follows:

Surface location 1730 feet from the North line and 900 feet from the West line;

bottomhole location at the top of the Pictured Cliffs formation 1482 feet from the North line and 836 feet from the West line;

and a bottomhole location at the base of the Pictured Cliffs formation 1442 feet from the North line and 826 feet from the West line.
