**APPLICATION OF NADEL AND GUSSMAN PERMIAN, L.L.C, FOR  
COMPULSORY POOLING, EDDY COUNTY, NEW MEXICO.**

**ORDER OF THE DIVISION**

**BY THE DIVISION;**

This case came on for hearing at 8:15 a.m. on March 3, 2005, at Santa Fe, New Mexico, before Examiner Richard I. Ezeanyim

NOW, on this 28<sup>th</sup> day of March, 2005, the Division Director, having considered the testimony, the record and the recommendations of the Examiner,

**FINDS THAT:**

(1) Due public notice has been given, and the Division has jurisdiction of this case and of the subject matter.

(2) The applicant, **Nadel and Gussman Permian, L.L.C.**, ("Applicant"), seeks an order pooling all uncommitted mineral interests from the surface to the base of the Morrow formation underlying the S/2 of Section 32, Township 22 South, Range 28 East, NMPM, Eddy County, New Mexico, in the following manner:

The S/2 to form a standard 320-acre gas spacing and proration unit for any and all formations **and/or** pools developed on **320-acre** spacing within that vertical extent, which includes but is not necessarily limited to the Dublin **Ranch-Atoka** Gas Pool, and Dublin Ranch-Morrow Gas Pool.

(3) The above-described unit ("the Unit") is simultaneously dedicated to the applicant's Brutus Well No. 1 located at a standard gas well location in SW/4SW/4 (Unit M) of Section 32, and the Grizzly Well No. 1 located at a standard gas well location in the NE/4SE/4 (Unit I) of Section 32.

(4) Two or more separately owned tracts are embraced within the Units, **and/or** there are royalty interests **and/or** undivided interests in oil and gas minerals in one or more tracts included in the Unit that are separately owned.

(5) Applicant is an owner of an oil and gas working interest within the Unit. Applicant has the right to drill and has drilled the two wells at standard gas well locations **in the S/2** of Section 32.

(6) There are interest owners in the proposed Unit that have not agreed to pool their interests.

(7) The Applicant provided notice pursuant to the applicable provisions of Division Rule 1207.A (1).

(8) This case was styled: "In the absence of objection, this matter will be taken under advisement."

(9) No affected party appeared at the hearing in opposition to this application.

(10) To avoid the drilling of unnecessary wells, protect correlative rights, prevent waste and afford to the owner of each interest in the Unit the opportunity to recover or receive without unnecessary expense its just and fair share of hydrocarbons, this application should be approved by pooling all uncommitted interests, whatever they may be, in the oil and gas within the Unit.

(11) The applicant requested to be designated the operator of the subject wells **and of the Unit**.

(12) Any pooled working interest owner who does not pay its share of actual well costs should have withheld from production its share of reasonable well costs plus an additional 200% (pursuant to Rule 35.A) thereof as a reasonable charge for the risk involved in drilling the well.

(13) Reasonable charges for supervision (combined fixed rates) should be fixed at \$7000.00 per month while drilling and \$700.00 per month while producing, provided that these rates should be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "*Accounting Procedure-Joint Operations*."

**IT IS THEREFORE ORDERED THAT ;**

(1) Pursuant to the application of **Nadel** and **Gussman** Permian, L.L.C. all uncommitted mineral interests from the surface to the base of the Morrow formation underlying the S/2 of Section 32, Township 22 South, Range 28 East, **NMPM**, Eddy County, New Mexico, are hereby pooled in the following manner:

The S/2 to form a standard 320-acre gas spacing and proration unit for any and all formations **and/or** pools developed on 320-acre spacing within that vertical extent, which includes but is not necessarily limited to the **Dublin Ranch-Atoka** Gas Pool, and **Dublin Ranch-Morrow** Gas Pool.

The above-described unit ("the Unit") is simultaneously dedicated to the applicant's Brutus Well No. 1 located at a standard gas well location in SW/4SW/4 (Unit M) of Section 32, and the Grizzly Well No. 1 located at a standard gas well location in the NE/4SE/4 (Unit I) of Section 32.

(2) **Nadel** and **Gussman** Permian, L.L.C., is hereby designated the operator of the subject wells and of the Unit.

(3) Upon final plugging and abandonment of the subject wells, the pooled Unit created by this Order shall terminate, unless this order has been amended to authorize further operations.

(4) After pooling, uncommitted working interest owners are referred to as pooled working interest owners. ("Pooled working interest owners" are owners of working interests in the Unit, including **un-leased** mineral interests, who are not parties to an operating agreement governing the Units.) After the effective date of this order, the operator shall furnish the Division and each known pooled working interest owner in the Unit an itemized schedule of actual costs of drilling, completing and equipping the subject wells ("**well costs**").

(5) Within 30 days from the date the schedule of actual well costs is furnished, any pooled working interest owner shall have the right to pay its share of actual well costs to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided, and any such owner who pays its share of actual well costs as provided above shall remain liable for operating costs but shall not be liable for

risk charges. Pooled working interest owners who elect not to pay their share of actual well costs as provided in this paragraph shall thereafter be referred to as "non-consenting working interest owners."

(6) The operator shall furnish the Division and each known pooled working interest owner (including non-consenting working interest owners) an itemized schedule of actual well costs within 90 days following completion of the proposed well. If no objection to the actual well costs is received by the Division, and the Division has not objected within 45 days following receipt of the schedule, the actual well costs shall be deemed to be the reasonable well costs. If there is an objection to actual well costs within the 45-day period, the Division will determine reasonable well costs after public notice and hearing.

(7) Within 60 days following determination of reasonable well costs, any pooled working interest owner who has paid its share of actual costs in advance as provided above shall pay to the operator its share of the amount that reasonable well costs exceed actual well costs and shall receive from the operator the amount, if any, that the actual well costs it has paid exceed its share of reasonable well costs.

(8) The operator is hereby authorized to withhold the following costs and charges from production:

- (a) the proportionate share of reasonable well costs attributable to each non-consenting working interest owner; and
- (b) as a charge for the risk involved in drilling the well, 200% of the above costs.

(9) The operator shall distribute the costs and charges withheld from production, proportionately, to the parties who advanced the well costs.

(10) Reasonable charges for supervision (combined fixed rates) are hereby fixed at \$7000.00 per month while **drilling** and \$700.00 per month while producing, provided that these rates shall be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "*Accounting Procedure-Joint Operations*." The operator is authorized to withhold from production the proportionate share of both the supervision charges and the actual expenditures required for operating the well, not in excess of what are reasonable, attributable to pooled working interest owners.

(11) Except as provided in Ordering Paragraphs (8) and (10) above, all proceeds from production from the well that are not disbursed for any reason shall be placed in escrow in Eddy County, New Mexico, to be paid to the true owner thereof upon demand and proof of ownership. The operator shall notify the Division of the name and address of the escrow agent within 30 days from the date of first deposit with the escrow agent.


(12) Any unleased mineral interest shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for the purpose of allocating costs and charges under this order. Any well costs or charges that are to be paid out of production shall be withheld only from the working interests' share of production, and no costs or charges shall be withheld from production attributable to royalty interests.

(13) Should all the parties to this compulsory pooling order reach voluntary agreement subsequent to entry of this order, this order shall thereafter be of no further effect.

(14) The operator of the wells and Unit shall notify the Division in writing of the subsequent voluntary agreement of all parties subject to the forced pooling provisions of this order.

(15) Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
