**APPLICATION OF MEWBOURNE OIL COMPANY FOR COMPULSORY  
POOLING, EDDY COUNTY, NEW MEXICO**

**ORDER OF THE DIVISION**

**BY THE DIVISION**

This case came on for hearing at 8 15 a m on March 2 2017 before Examiner Michael A McMillan and again on March 30 before Examiner Phillip R Goetze

NOW on this 8<sup>th</sup> day of May 2017 the Division Director having considered the testimony the record and the recommendations of Examiner McMillan,

**FINDS THAT**

(1) Due public notice has been given and the Division has jurisdiction of this case and of the subject matter

(2) Mewbourne Oil Company (' Applicant' or Mewbourne ') seeks an order pooling all uncommitted interests in the Wolfcamp formation Purple Sage Wolfcamp (Gas) Pool (Pool code 98220) underlying the E/2 of Section 21 Township 23 South Range 28 East NMPM Eddy County New Mexico, forming a standard 320 acre gas spacing unit (the Unit )

(3) The Unit will be dedicated to the Applicant s Loving Townsite 21 W2PA Fee Well No 1H (the proposed well API No 30-015 43496), a horizontal well to be drilled from a surface location 220 feet from the North line and 450 feet from the East line (Unit A) of Section 28 Township 23 South Range 28 East to a terminus or bottom hole location 330 feet from the North line and 450 feet from the East line (Unit A) of Section 21, Township 23 South Range 28 East The location of the completed interval will be orthodox within the Unit

(4) Division records indicate that the subject well has been drilled at a surface location 220 feet from the North line and 210 feet from the East line (Unit A) of Section 28 to a bottom hole location 330 feet from the North line and 450 feet from the East line (Unit A) of Section 21 both in Township 23 South Range 28 East NMPM Eddy County New Mexico

(5) The proposed well is within the Purple Sage Wolfcamp (Gas) Pool (Pool code 98220) which is governed by special pool rules as established by Division Order No R 14262 which provide for 320 acre gas spacing units with wells to be located no closer than 330 feet from a unit outer boundary

(6) Applicant appeared at the hearing through counsel and presented land evidence to the effect that

- (a) The Wolfcamp formation in this area is suitable for development by horizontal drilling
- (b) the proposed orientation of the horizontal well from North to South or South to North is appropriate for the proposed Unit,
- (c) The proposed gas spacing unit is standard for the Purple Sage Wolfcamp (Gas) Pool
- (d) notice was provided to all interest owners subject to pooling proceedings as affected parties of the proposed compulsory pooling within the Unit and
- (e) Applicant provided notice of this application by publication before hearing in a newspaper of general circulation in Eddy County New Mexico the county in which the property is located for the unlocatable interests

(7) No other party appeared at the hearing or otherwise opposed the granting of this application

The Division concludes that

(8) Two or more separately owned tracts are embraced within the Unit and/or there are royalty interests and/or undivided interests in oil and gas minerals in one or more tracts included in the Unit that are separately owned

(9) Applicant is owner of an oil and gas working interest within the Unit Applicant has the right to drill and has drilled the proposed well to a common source of supply within the Unit at the proposed location

(10) There are interest owners in the Unit that have not agreed to pool their interests

(11) To avoid the drilling of unnecessary wells protect correlative rights, prevent waste and afford to the owner of each interest in the Unit the opportunity to recover or receive without unnecessary expense its just and fair share of hydrocarbons this application should be approved by pooling all uncommitted interests whatever they may be in the oil and gas within the Unit

(12) Mewbourne should be designated the operator of the proposed well and the Unit

(13) Any pooled working interest owner who does not pay its share of estimated well costs should have withheld from production its share of reasonable well costs plus an additional 200% thereof as a reasonable charge for the risk involved in drilling the proposed well

(14) Reasonable charges for supervision (combined fixed rates) should be fixed at \$7 500 per month while drilling and \$750 per month while producing provided that these rates should be adjusted annually pursuant to Section III 1 A 3 of the COPAS form titled 'Accounting Procedure Joint Operations

**IT IS THEREFORE ORDERED THAT**

(1) Pursuant to the application of Mewbourne Oil Company all uncommitted interests whatever they may be in the oil and gas in the Wolfcamp formation, Purple Sage Wolfcamp (Gas) Pool (Pool code 98220) underlying the E/2 of Section 21 Township 23 South Range 28 East NMPM Eddy County New Mexico (the Unit ) are hereby pooled

(2) The Unit shall be dedicated to the Applicant s Loving Townsite 21 W2PA Fee Well No 1H (the subject well API No 30-015 43496) a horizontal well drilled from a surface location 220 feet from the North line and 210 feet from the East line (Unit A) of Section 28 Township 23 South Range 28 East to a terminus or bottom hole location 330 feet from the North line and 450 feet from the East line (Unit A) of Section 21 Township 23 South Range 28 East The completed interval of the proposed well within the Unit will be orthodox

(3) Should the subject well not be completed within 120 days after commencement thereof then Ordering Paragraph (1) shall be of no further effect, and the unit created by this order shall terminate unless operator appears before the Division Director and obtains an extension of the time for completion of the proposed well for good cause shown by satisfactory evidence

(4) Upon final plugging and abandonment of the subject well and any other well drilled on the Unit pursuant to Division Rule 19 15 13 9 NMAC the Unit created by

this Order shall terminate unless this Order has been amended to authorize further operations

(5) Mewbourne Oil Company (OGRID 228937) is hereby designated the operator of the well and the Unit

(6) After pooling, uncommitted working interest owners are referred to as pooled working interest owners ('Pooled working interest owners are owners of working interests in the Unit including unleased mineral interests who are not parties to an operating agreement governing the Unit) After the effective date of this order the operator shall furnish the Division and each known pooled working interest owner in the Unit an itemized schedule of estimated costs of drilling completing and equipping the subject well ( well costs )

(7) Within 30 days from the date the schedule of actual well costs is furnished, any pooled working interest owner shall have the right to pay its share of actual well costs to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided and any such owner who pays its share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges Pooled working interest owners who elect not to pay their share of estimated well costs as provided in this paragraph shall thereafter be referred to as non-consenting working interest owners

(8) The operator shall furnish the Division and each known pooled working interest owner (including non consenting working interest owners) an itemized schedule of actual well costs within 90 days following completion of the subject well If no objection to the actual well costs is received by the Division and the Division has not objected within 45 days following receipt of the schedule the actual well costs shall be deemed to be the reasonable well costs If there is an objection to actual well costs within the 45 day period the Division will determine reasonable well costs after public notice and hearing

(9) Within 60 days following determination of reasonable well costs, any pooled working interest owner who has paid its share of actual costs in advance as provided above shall pay to the operator its share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator the amount, if any, that the actual well costs it has paid exceed its share of reasonable well costs

(10) The operator is hereby authorized to withhold the following costs and charges from production from each well

- (a) the proportionate share of reasonable well costs attributable to each non consenting working interest owner and

- (b) as a charge for the risk involved in drilling the well  
200% of the above costs

(11) The operator shall distribute the costs and charges withheld from production proportionately to the parties who advanced the well costs

(12) Reasonable charges for supervision (combined fixed rates) for the well are hereby fixed at \$7 500 per month while drilling and \$750 per month while producing, provided that these rates shall be adjusted annually pursuant to Section III 1 A 3 of the COPAS form titled *Accounting Procedure Joint Operations*. The operator is authorized to withhold from production the proportionate share of both the supervision charges and the actual expenditures required for operating the well not in excess of what are reasonable attributable to pooled working interest owners

(13) Except as provided in Paragraphs (10) and (12) above, all proceeds from production from the subject well that are not disbursed for any reason shall be held for the account of the person or persons entitled thereto pursuant to the Oil and Gas Proceeds Payment Act (NMSA 1978 Sections 70-10-1 through 70-10-6 as amended). If not disbursed such proceeds shall be turned over to the appropriate authority as and when required by the Uniform Unclaimed Property Act (NMSA 1978 Sections 7-8A-1 through 7-8A-31 as amended)


(14) Any unleased mineral interests shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for the purpose of allocating costs and charges under this order. Any well costs or charges that are to be paid out of production shall be withheld only from the working interests share of production and no costs or charges shall be withheld from production attributable to royalty interests

(15) Should all the parties to this compulsory pooling order reach voluntary agreement subsequent to entry of this Order this Order shall thereafter be of no further effect

(16) The operator of the well and Unit shall notify the Division in writing of the subsequent voluntary agreement of parties subject to the compulsory pooling provisions of this Order

(17) Jurisdiction of this case is retained for the entry of such further Order as the Division may deem necessary
