Pursuant to Section 10 of the San Juan 32-8 Unit Agreement, Hilcorp Energy Company ("Hilcorp"), as Unit Operator, hereby submits the proposed 2019 Plan of Development and Operations ("2019 POD") to the Bureau of Land Management.

I. PERIOD

This plan will be effective from April 1, 2019 through March 31, 2020. The 2020 Plan will be submitted on or before March 1, 2020.

II. 2018 PLAN REVIEW OF OPERATIONS

A summary of key activities undertaken on or after April 1, 2018 include:

A. Production History: During 2018, approximate cumulative production from the San Juan 32-8 Unit was 40 barrels of oil; 13.3 (BCF) gas; and 407.3 (MBW) produced water. Refer to Exhibit A attached for a listing of all wells.

B. Participating Areas: The Participating Areas currently established in the San Juan 32-8 Unit are:
