**2019 PLAN OF DEVELOPMENT  
FOR THE COX CANYON UNIT (NMNM-078388X),  
T32N-R11W, SAN JUAN COUNTY, NEW MEXICO**

Pursuant to Section 10 of the Cox Canyon Unit Agreement, Hilcorp Energy Company (“Hilcorp”), as Unit Operator, hereby submits the proposed 2019 Plan of Development and Operations (“2019 POD”) to the Bureau of Land Management.

**I. PERIOD**

This plan will be effective from April 1, 2019 through March 31, 2020. The 2020 Plan will be submitted on or before March 1, 2020.

**II. 2018 PLAN REVIEW OF OPERATIONS**

A summary of key activities undertaken on or after April 1, 2018 include:

**A. Production History:** During 2018, approximate cumulative production from the Cox Canyon Unit was 366 barrels of oil; 1.6 (BCF) of gas; and 216 barrels of produced water. Refer to Exhibit A attached for a listing of all wells.

**B. Participating Areas:** The Participating Areas currently established are:

**C. Drilling Program:** The 2018 POD filed by Hilcorp did not indicate any anticipated activity. Throughout 2018, no drilling occurred in the Cox Canyon Unit; there is therefore no status update to provide.

- D. Workovers/Recompletion Program:** The 2018 POD filed by Hilcorp did not indicate any anticipated activity. Throughout 2018, no workovers and/or recompletions were completed in the Cox Canyon Unit; there is therefore no status update to provide.
- E. Facility Program:** The 2018 POD filed by Hilcorp did not indicate any anticipated activity. Throughout 2018, no facility projects were completed in the Cox Canyon Unit; there is therefore no status update to provide.
- F. Plugging & Abandonment Program:** The 2018 POD filed by Hilcorp did not indicate any anticipated activity. Throughout 2018, no plugging and abandonment projects were completed in the Cox Canyon Unit; there is therefore no status update to provide.

- B. Workovers/Recompletion Program:** Hilcorp has no immediate plans for workovers and/or recompletions in the Cox Canyon Unit. Throughout 2019, ongoing evaluation efforts may result in the execution of additional opportunities.
- C. Facility Program:** Hilcorp has no immediate plans for facility projects in the Cox Canyon Unit. Throughout 2019, Hilcorp will conduct routine repairs and replacement of facilities required to maintain and increase field production, including construction of additional gas lift lines and/or gas flow lines, expansion of production facilities(including electrical and piping upgrades), and construction of additional water disposal, injection or processing equipment.
- D. Plugging & Abandonment Program:** Hilcorp has no immediate plans for plugging and abandonment in the Cox Canyon Unit. Throughout 2019, ongoing evaluation efforts may result in the execution of additional opportunities or obligations.
