ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on November 9, 2006, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this 4<sup>th</sup> day of December, 2006, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Atoka formation, bearing the designation of Maroon Cliffs-Atoka Gas Pool (**Pool Code 97557**). The Maroon Cliffs-Atoka Gas Pool was discovered by the BEPCO, L.P. Big Eddy Unit Well No. 44 (**API No. 30-015-21529**) located in Unit H of Section 16, Township 21 South, Range 30 East, NMPM, which was completed in the Atoka formation on September 21, 2006. The top of the perforations is at 11,988 feet.

(3) There is need for extensions to the Angell Ranch-Atoka-Morrow Gas Pool, the Benson-Delaware Pool, the Brushy Draw-Delaware Pool, the Bunting Ranch-Morrow Gas Pool, the Burton Flat-Atoka Gas Pool, the Cass Ranch-Upper Pennsylvanian Gas Pool, the Cedar Canyon-Delaware Pool, the Chosa Draw-Morrow Gas Pool, the Collins Ranch-Wolfcamp Gas Pool, the Northwest Corral Canyon-Delaware Pool, the

Cottonwood Creek-Wolfcamp Gas Pool, the West Cottonwood Creek-Wolfcamp Gas Pool, the Cottonwood Draw-Delaware Pool, the Crow Flats-Morrow Gas Pool, the Southwest Four Mile Draw-Wolfcamp Gas Pool, the Golden Lane-Atoka Gas Pool, the Southeast Greenwood-Morrow Gas Pool, the Laguna Salado-Bone Spring Pool, the Little Box Canyon-Morrow Gas Pool, the Mosley Canyon-Strawn Gas Pool, the East Pierce Crossing-Bone Spring Pool, the Rocky Arroyo-Canyon Gas Pool, and the Sand Tank-Bone Spring Pool, all in Eddy County, New Mexico.

IT IS THEREFORE ORDERED THAT:

(a) A new pool in Eddy County, New Mexico classified as a gas pool for Atoka production is hereby created and designated as the Maroon Cliffs-Atoka Gas Pool (**Pool Code 97557**), consisting of the following described area:



IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations and extensions included herein shall be December 1, 2006.
