EXTENDING CERTAIN POOLS IN CHAVES AND
EDDY COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on June 7, 2007, at Santa Fe, New Mexico before Examiner David K. Brooks.

NOW, on this 13th day of June, 2007, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the Delaware formation, bearing the designation of Hay Hollow-Delaware Pool (**Pool Code** 97596). The Hay Hollow-Delaware Pool was discovered by the BTA Oil Producers Owl 20504 **JV-P** Well No. 1 (**API** No. 30-015-34749) located in Unit K of Section 18, Township 26 South, Range 27 East, **NMPM**, which was completed in the Delaware formation on July 13, 2006. The top of the perforations is at 4,062 feet.

(3) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Upper **Pennsylvanian** formation, bearing the designation of Salt Draw-Upper Pennsylvanian Gas Pool (Pool Code 97594). The Salt Draw-Upper Pennsylvanian Gas Pool was discovered by the **OGX** Resources, LLC **EKG** Fee Well No. 1 (**API** No. 30-015-33907) located in Unit E of Section 29, Township 24

South, Range 28 East, NMPM, which was completed in the Upper Pennsylvanian formation on May 23, 2006. The top of the perforations is at 11,010 feet.

(4) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the **Wolfcamp** formation, bearing the designation of South White City-Wolfcamp Gas Pool (Pool Code 97592). The South White City-Wolfcamp Gas Pool was discovered by the Samson Resources Company Pine Springs 2 State Well No. 1 (API No. 30-015-33562) located in Unit E of Section 2, Township 26 South, Range 25 East, NMPM, which was completed in the Wolfcamp formation on February 4, 2007. The top of the perforations is at 9,823 feet.

(5) There is need for extensions to the **Artesia-Queen-Grayburg-San Andres** Pool, the **Avalon-Upper Pennsylvanian** Gas Pool, the **Bear Grass Draw-Abo** Pool, the **Big Sinks-Delaware** Pool, the **Black River-Morrow** Gas Pool, the **East Burton Flat-Morrow** Gas Pool, the **East Carlsbad-Morrow** Gas Pool, the **Cottonwood Creek-Wolfcamp** Gas Pool, the **West Cottonwood Creek-Wolfcamp** Gas Pool, the **Crooked Canyon-Atoka-Morrow** Gas Pool, the **Empire-Abo** Pool, the **Four Mile Draw-Wolfcamp** Gas Pool, the **Southwest Four Mile Draw-Wolfcamp** Gas Pool, the **Golden Lane-Atoka** Gas Pool, the **Hackberry Hills-Canyon** Gas Pool, the **Happy Valley-Morrow** Gas Pool, the **West Malaga-Morrow** Gas Pool, the **Mosley Canyon-Upper Pennsylvanian** Gas Pool, the **Nash Draw-Delaware/Bone Spring (Avalon Sand)** Pool, the **Penasco Draw-Permo Pennsylvanian** Gas Pool, the **East Pierce Crossing-Bone Spring** Pool, the **Rio Penasco-Wolfcamp** Gas Pool, the **Salt Draw-Atoka** Gas Pool, the **West Sand Dunes-Atoka** Gas Pool, the **West Sand Dunes-Delaware** Pool, the **Sand Tank-Morrow** Gas Pool, the **Sheep Draw-Strawn** Gas Pool, the **Tamano-Bone Spring** Pool and the **Willow Lake-Delaware** Pool, all in Eddy County, New Mexico; and the **Lake Arthur-Wolfcamp** Gas Pool in Chaves County, New Mexico; and the **Lusk-Bone Spring** Pool in Lea County, New Mexico to include acreage in Eddy County, New Mexico.

IT IS THEREFORE ORDERED THAT:

(a) A new pool in Eddy County, New Mexico classified as an oil pool for Delaware production is hereby created and designated as the Hay Hollow-Delaware Pool (Pool Code 97596), consisting of the following described area:

(c) A new pool in Eddy County, New Mexico classified as a gas pool for Wolfcamp production is hereby created and designated as the South White City-Wolfcamp Gas Pool (**Pool Code 97592**), consisting of the following described area:

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above **pool** extensions, is subject to pool rules providing for

spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations and extensions included herein shall be July 1, 2007.

(3) Jurisdiction of this case is hereby retained for the entry of such further orders as the Division may deem necessary.
