VERTICAL AND HORIZONTAL LIMITS, AND
REDESIGNATING CERTAIN POOLS IN CHAVES
AND EDDY COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on September 4, 2003, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 24th day of September, 2003, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Siluro Devonian formation, bearing the designation of Alkali Draw-Siluro Devonian Gas Pool (**Pool Code 97284**). The Alkali Draw-Siluro Devonian Gas Pool was discovered by the Yates Petroleum Corporation Bobwhite "BBH" Deep Federal Com. Well No. 1 (**API No. 30-005-62135**) located in Unit D of Section 3, Township 6 South, Range 26 East, NMPM, which was completed in the Siluro Devonian formation on May 11, 2003. The top of the perforations is at 5,364 feet.

(3) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Strawn formation, bearing the designation of Angel Ranch-Strawn Gas Pool (**Pool Code 97278**). The Angel Ranch-Strawn Gas

Pool was discovered by the EOG Resources, Inc. Gordon "23" State Com. Well No. 1 (API No. 30-015-32353) located in Unit N of Section 23, Township 19 South, Range 27 East, NMPM, which was completed in the **Strawn** formation on March 18, 2003. The top of the perforations is at 9,754 feet.

(4) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the **Wolfcamp** formation, bearing the designation of South Crockett **Draw-Wolfcamp** Gas Pool (Pool Code 97285). The South Crockett **Draw-Wolfcamp** Gas Pool was discovered by the Yates Petroleum Corporation Cottonwood Federal Well No. 5 (API No. 30-005-63448) located in Unit J of Section 26, Township 6 South, Range 25 East, NMPM, which was completed in the Wolfcamp formation on April 10, 2002. The top of the perforations is at 4,900 feet.

(5) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Cisco-Canyon formation, bearing the designation of Dog Canyon Draw-Upper **Pennsylvanian** Pool (Pool Code 97287). The Dog Canyon Draw-Upper Pennsylvanian Pool was discovered by the Yates Petroleum Corporation Gem Dandy "BCG" State Com. Well No. 1 (API No. 30-015-32666) located in Unit L of Section 35, Township 16 South, Range 27 East, NMPM, which was completed in the Cisco-Canyon formation on May 9, 2003. The top of the perforations is at 7,652 feet.

(6) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Wolfcamp formation, bearing the designation of Northwest **Empire-Wolfcamp** Pool (Pool Code 97286). The Northwest Empire-Wolfcamp Pool was discovered by the Yates Petroleum Corporation Gem Dandy "BCG" State Com. Well No. 1 (API No. 30-015-32666) located in Unit L of Section 35, Township 16 South, Range 27 East, NMPM, which was completed in the Wolfcamp formation on May 13, 2003. The top of the perforations is at 6,064 feet.

(7) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Bone Spring formation, bearing the designation of South **Esperanza-Bone** Spring Pool (Pool Code 97277). The South **Esperanza-Bone** Spring Pool was discovered by the Devon Energy Production Company, L.P. Indian Draw "13" Well No. 1 (API No. 30-015-29714) located in Unit K of Section 13, Township 22 South, Range 27 East, NMPM, which was completed in the Bone Spring formation on March 26, 2003. The top of the perforations is at 7,670 feet.

(8) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Wolfcamp formation, bearing the designation of Lost **Lake-Wolfcamp** Gas Pool (Pool Code 97281). The Lost **Lake-Wolfcamp** Gas Pool was discovered by the Yates Petroleum Corporation Summers Com. Well No. 2 (API No. 30-005-63469) located in Unit M of Section 25,

Township 9 South, Range 24 East, NMPM, which was completed in the Wolfcamp formation on July 2, 2003. The top of the perforations is at 4,496 feet.

(9) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Bone Spring formation, bearing the designation of Rattlesnake Well-Bone Spring Gas Pool (Pool Code 97279). The Rattlesnake Well-Bone Spring Gas Pool was discovered by the Ocean Energy, Inc. Parkway Well No. 19 (API No. 30-015-32663) located in Unit K of Section 21, Township 19 South, Range 29 East, NMPM, which was completed in the Bone Spring formation on April 11, 2003. The top of the perforations is at 6,810 feet.

(10) There is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the **Strawn** formation, bearing the designation of Rattlesnake **Well-Strawn** Pool (Pool Code 97280). The Rattlesnake **Well-Strawn** Pool was discovered by the OXY USA, Inc. OXY Pearl State Well No. 2 (API No. 30-015-30851) located in Unit A of Section 32, Township 19 South, Range 29 East, NMPM, which was completed in the Strawn formation on April 14, 2000. The top of the perforations is at 10,315 feet.

(11) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Atoka formation, bearing the designation of **Windmill-Atoka** Gas Pool (Pool Code 97289). The **Windmill-Atoka** Gas Pool was discovered by the Yates Petroleum Corporation Ten Mile Unit Well No. 1 (API No. 30-005-63509) located in Unit G of Section 33, Township 14 South, Range 28 East, NMPM, which was completed in the Atoka formation on March 1, 2003. The top of the perforations is at 8,549 feet.

(12) There is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Strawn formation, bearing the designation of **Windmill-Strawn** Gas Pool (Pool Code 97288). The **Windmill-Strawn** Gas Pool was discovered by the Yates Petroleum Corporation Ten Mile Unit Well No. 1 (API No. 30-005-63509) located in Unit G of Section 33, Township 14 South, Range 28 East, NMPM, which was completed in the Strawn formation on March 15, 2003. The top of the perforations is at 8,424 feet.

(13) There is need for the extension of the vertical limits of the **Clayton Basin-Seven Rivers** Pool (Pool Code 97238) in Eddy County, New Mexico, to include the Yates formation and the **redesignation** of the pool as the Clayton Basin-Yates-Seven Rivers Pool.

(14) There is need for extensions to the **Burton Flat-Morrow** Gas Pool, the **East Carlsbad-Morrow** Gas Pool, the **Cedar Canyon-Delaware** Pool, the **Cemetery-Morrow** Gas Pool, the **Clayton Basin-Yates-Seven Rivers** Pool, the **Crow Flats-Morrow** Gas Pool, the **Happy Valley-Delaware** Pool, the **Ingle Wells-Delaware** Pool, the **Laguna Salado-Bone Spring** Pool, the **Loco Hills-Wolfcamp** Pool, the **South Los Medanos-Wolfcamp** Pool, the **North McMillan-Morrow** Gas Pool, the **Otis-Morrow**

Gas Pool, the Owen Mesa-Wolfcamp Gas Pool, the Runyan Ranch-Abo Gas Pool, the South Sand Dunes-Delaware Pool, the North Seven Rivers Hills-Atoka Gas Pool, and the Shugart-Morrow Gas Pool, all in Eddy County, New Mexico; and the North Foor Ranch-Pre-Permian Gas Pool and the Foor Ranch-Wolfcamp Gas Pool, both in Chaves County, New Mexico.

IT IS THEREFORE ORDERED THAT:

(a) A new pool in Chaves County, New Mexico classified as a gas pool for Siluro Devonian production is hereby created and designated as the Alkali Draw-Siluro Devonian Gas Pool (Pool Code 97284), consisting of the following described area:

TOWNSHIP 6 SOUTH. RANGE 26 EAST. NMPM
Section 3: All

(b) A new pool in Eddy County, New Mexico classified as a gas pool for Strawn production is hereby created and designated as the Angel Ranch-Strawn Gas Pool (Pool Code 97278), consisting of the following described area:

TOWNSHIP 19 SOUTH. RANGE 27 EAST. NMPM
Section 23: S/2

(c) A new pool in Chaves County, New Mexico classified as a gas pool for Wolfcamp production is hereby created and designated as the South Crockett Draw-Wolfcamp Gas Pool (Pool Code 97285), consisting of the following described area:

TOWNSHIP 6 SOUTH. RANGE 25 EAST. NMPM
Section 26: E/2

(d) A new pool in Eddy County, New Mexico classified as an oil pool for Cisco-Canyon production is hereby created and designated as the Dog Canyon Draw-Upper Pennsylvanian Pool (Pool Code 97287), consisting of the following described area:

TOWNSHIP 16 SOUTH. RANGE 27 EAST. NMPM
Section 35: SW/4

(e) A new pool in Eddy County, New Mexico classified as an oil pool for Wolfcamp production is hereby created and designated as the Northwest Empire-Wolfcamp Pool (Pool Code 97286), consisting of the following described area:

TOWNSHIP 16 SOUTH. RANGE 27 EAST. NMPM
Section 35: SW/4

(f) A new pool in Eddy County, New Mexico classified as an oil pool for Bone Spring production is hereby created and designated as the South Esperanza-Bone Spring Pool (Pool Code 97277), consisting of the following described area:

Section 13: SW/4

(g) A new pool in Chaves County, New Mexico classified as a gas pool for Wolfcamp production is hereby created and designated as the Lost Lake-Wolfcamp Gas Pool (Pool Code 97281), consisting of the following described area:

(h) A new pool in Eddy County, New Mexico classified as a gas pool for Bone Spring production is hereby created and designated as the Rattlesnake Well-Bone Spring Gas Pool (Pool Code 97279), consisting of the following described area:

Section 21: SW/4

(i) A new pool in Eddy County, New Mexico classified as an oil pool for Strawn production is hereby created and designated as the Rattlesnake Well-Strawn Pool (Pool Code 97280), consisting of the following described area:

(j) A new pool in Chaves County, New Mexico classified as a gas pool for Atoka production is hereby created and designated as the Windmill-Atoka Gas Pool (Pool Code 97289), consisting of the following described area:


IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to

the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations, redesignations of pools, and extensions of vertical and horizontal limits included herein shall be October 1, 2003.
