EDDY COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on October 3, 2007, at Santa Fe, New Mexico, before Examiner David K. Brooks.

NOW, on this 22nd day of October, 2007, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Wolfcamp formation, bearing the designation of Bunting Ranch-Wolfcamp Gas Pool (**Pool Code 97605**). The Bunting Ranch-Wolfcamp Gas Pool was discovered by the Parallel Petroleum Corporation Drewford's Boom Box 1921-1 State Com. Well No. 1 (**API No. 30-015-35134**) located in Unit D of Section 19, Township 19 South, Range 21 East, NMPM, which was completed in the Wolfcamp formation on February 9, 2006. The top of the perforations is at 4,210 feet.

(3) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Chester formation, bearing the designation of Cemetery-Chester Gas Pool (**Pool Code 97624**). The Cemetery-Chester Gas Pool was discovered by the Yates Petroleum Corporation Conoco AGX Deep Federal Well No. 4 (**API No. 30-015-26735**) located in Unit A of Section 26, Township 20 South, Range 24

East, NMPM, which was completed in the Chester formation on June 14, 2007. The top of the perforations is at 9,532 feet.

(4) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Atoka formation, bearing the designation of Goar Corral-Atoka Gas Pool (**Pool Code 97606**). The Goar Corral-Atoka Gas Pool was discovered by the Marbob Energy Corporation Mule 24 Federal Com. Well No. 2 (**API No. 30-015-21203**) located in Unit G of Section 24, Township 24 South, Range 25 East, NMPM, which was completed in the Atoka formation on March 13, 2007. The top of the perforations is at 10,952 feet.

(5) There is need for the creation of a new pool in Chaves County, New Mexico for the production of gas from the Wolfcamp formation, bearing the designation of Hagerman Canal-Wolfcamp Gas Pool (**Pool Code 97604**). The Hagerman Canal-Wolfcamp Gas Pool was discovered by the Parallel Petroleum Corporation War Cloud 1425-36 State Com. Well No. 1 (**API No. 30-005-63881**) located in Unit P of Section 36, Township 14 South, Range 25 East, NMPM, which was completed in the Wolfcamp formation on February 28, 2007. The top of the perforations is at 5,490 feet.

(6) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Wolfcamp formation, bearing the designation of West Hay Hollow-Wolfcamp Gas Pool (**Pool Code 97625**). The West Hay Hollow-Wolfcamp Gas Pool was discovered by the Chesapeake Operating, Inc. Hayhurst 16 State Well No. 1 (**API No. 30-015-35114**) located in Unit P of Section 16, Township 25 South, Range 27 East, NMPM, which was completed in the Wolfcamp formation on April 4, 2007. The top of the perforations is at 10,196 feet.

(7) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the Abo formation, bearing the designation of Ishee Lake-Abo Pool (**Pool Code 97627**). The Ishee Lake-Abo Pool was discovered by the Mack Energy Corporation Bears Federal Well No. 1 (**API No. 30-015-35409**) located in Lot 16 of Section 6, Township 16 South, Range 29 East, NMPM, which was completed in the Abo formation on April 20, 2007. The top of the perforations is at 6,938 feet.

(8) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the San Andres formation, bearing the designation of Ishee Lake-San Andres Pool (**Pool Code 97628**). The Ishee Lake-San Andres Pool was discovered by the Mack Energy Corporation Colts Federal Well No. 1 (**API No. 30-015-35410**) located in Lot 16 of Section 5, Township 16 South, Range 29 East, NMPM, which was completed in the San Andres formation on April 26, 2007. The top of the perforations is at 2,783 feet.

(9) There is need for the creation of a new pool in Eddy County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of Northeast Loco Hills-Wolfcamp Pool (**Pool Code 97639**). The Northeast Loco Hills-Wolfcamp Pool was discovered by the Cimarex Energy Company of Colorado Keely 26

Federal Well No. 1 (**API No. 30-015-35025**) located in Unit G of Section 26, Township 17 South, Range 29 East, NMPM, which was completed in the Wolfcamp formation on November 17, 2006. The top of the perforations is at 9,078 feet.

(10) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Strawn formation, bearing the designation of Salt Draw-Strawn Gas Pool (**Pool Code 97638**). The Salt Draw-Strawn Gas Pool was discovered by the Marbob Energy Corporation Moody Fee Com. Well No. 1 (**API No. 30-015-34638**) located in Unit P of Section 18, Township 25 South, Range 28 East, NMPM, which was completed in the Strawn formation on April 22, 2007. The top of the perforations is at 11,694 feet.

(11) There is need for the creation of a new pool in Chaves County, New Mexico for the production of gas from the Wolfcamp formation, bearing the designation of Walnut Creek-Wolfcamp Gas Pool (**Pool Code 97631**). The Walnut Creek-Wolfcamp Gas Pool was discovered by the Parallel Petroleum Corporation Forego 1525-16 Well No. 1 (**API No. 30-005-63830**) located in Unit B of Section 16, Township 15 South, Range 25 East, NMPM, which was completed in the Wolfcamp formation on November 16, 2006. The top of the perforations is at 5,240 feet.

(12) There is need for the contraction of the South Loving-Delaware Pool (**Pool Code 40380**) in Eddy County, New Mexico in order to correct nomenclature. The deleted acreage will be placed in the East Loving-Brushy Canyon Pool (**Pool Code 40350**).

(13) There is need for extensions to the Azotea Mesa-Bone Spring Pool, the Buzzard Canyon-Wolfcamp Gas Pool, the South Carlsbad-Morrow Gas Pool, the Cass Draw-Delaware Pool, the Cemetery-Morrow Gas Pool, the Collins Ranch-Wolfcamp Gas Pool, the Northwest Corral Canyon-Delaware Pool, the Cottonwood Creek-Wolfcamp Gas Pool, the West Cottonwood Creek-Wolfcamp Gas Pool, the Dagger Draw-Wolfcamp Gas Pool, the North Duffield-Strawn Gas Pool, the Eagle Creek-Wolfcamp Gas Pool, the Four Mile Draw-Wolfcamp Gas Pool, the Southwest Four Mile Draw-Wolfcamp Gas Pool, the Horseshoe Bend-Morrow Gas Pool, the Laguna Salado-Atoka Gas Pool, the McKittrick Canyon-Upper Pennsylvanian Gas Pool, the Nash Draw-Morrow Gas Pool, the Sand Tank-Bone Spring Pool, the North Seven Rivers-Wolfcamp Gas Pool and the Sheep Draw-Morrow Gas Pool, all in Eddy County, New Mexico; and the Coyote-Wolfcamp Gas Pool and the Sand Draw-Abo Gas Pool, both in Chaves County, New Mexico.

IT IS THEREFORE ORDERED THAT:

(a) A new pool in Eddy County, New Mexico classified as a gas pool for Wolfcamp production is hereby created and designated as the Bunting Ranch-Wolfcamp Gas Pool (**Pool Code 97605**), consisting of the following described area:

(b) A new pool in Eddy County, New Mexico classified as a gas pool for Chester production is hereby created and designated as the Cemetery-Chester Gas Pool (**Pool Code 97624**), consisting of the following described area:


IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations, contractions and extensions included herein shall be November 1, 2007.

(3) Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
