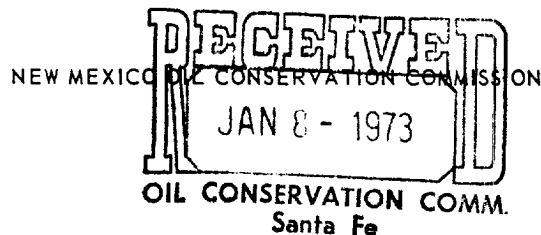

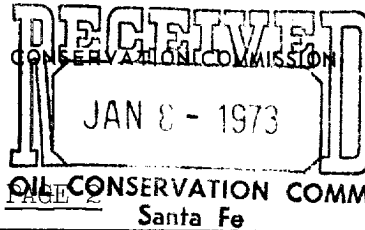

- (3) two stages as follows: 1st stage - 600 sx lite w/.75% CFR-2, followed by 200 sx Class "C", 1% CFR-2. Plug down 9:55 PM. Dropped bomb, op'd DV collar, and circ out approx 10 sx cmt, circ w/rig pump until 1 AM. Began 2nd stage at 2 AM w/500 sx Class "C", 1% CFR-2. Closed DV collar 2:45 AM. Cmt failed to circ but found cmt within 10' of sfc. Rec'd 30 BW placed ahead of cmt. Pumped 70 bbls slurry before losing circ. Tested to 2,000 psi, ok.
