TD of well is 4638'. 13-3/8" csg. set at 390' with cement circulated. 10-3/4" csg set at 1374' - mudded off. 8-5/8" csg set at 2558' and cemented with 75 sacks. Verbal instructions from Mr. McGrath (USGS Engineer at Farmington) were to spot cement plug from 4200' to 4300', one in surface pipe and to leave 4' pipe marked extending up from abandoned well head.
