The operator of the subject well never furnished the required forms advising the Oil Commission as to how the well was drilled, the condition of the hole and the conditions encountered therein, even though such a demand was repeatedly made by this office. By examining the Scout Reports, it appears that the well was drilled to a total depth of 3604 feet. It was spudded on 10-20-58 and apparently the operator quit drilling on 8-5-59. Ten and three-quarter inch casing was set at 120 feet and cemented with with cement, we estimate that it will take some 1800 sacks to accomplish this work.

If you can find out from the principal how the well was crilled, what conditions were encountered and what the condition of the hole is, our District Engineer could probably devise a normal plugging program which in all probability would not take edequate data on a well the only acceptable plugging program in order to adequately protect the fresh waters and the oil and gas bearing strata has to be a cement plug from top to bottom.

Mr. Vernon O. Gardner, 2132 Freemont Drive, Oklahoma City 20, Oklahoma, advised us on October 8, 1959 that he would file the well but his letter does indicate that they are available somewhere. So it would behoove you, in the interest of a cheaper plugging program, to somehow force the principal or Mr. Vernon Gardner, their agent, to furnish this information to you so that a drilling company would have some idea of how much to bid on the job.

I would like to emphasize, however, that in any event this rear future.
