A 12-1/4" hole was spudded October 18, 1974, and drilled to 114'. The 8-5/8" casing was set at 111' with 120 sacks Class "A" cement with 2% CaCl with 2 pounds Tuf Plug per sack on October 18, 1974. Circulated 30 sacks cement. Tested 8-5/8" casing and blowout preventer with 250 psi OK. Reduced hole to 6-1/2" at 114' and continued drilling.
