JAMES A. HARRISON, being first duly sworn according to law, upon his oath deposes and says:

1. That he is President of HNG Resources, Inc., whose address is 1200 Travis Street, Houston, Texas 77002.

2. That HNG Resources, Inc., is the operator of a well drilled on land belonging to J. A. Whittenburg III, whose address is 620 South Taylor, Amarillo, Texas 79101, J. A. Whittenburg, Jr., Testamentary Trust, and Catharine C. Whittenburg, Testamentary Trust ("Landowners"), said well being drilled to test for hydrocarbons and/or carbon dioxide gas and described as the T. L. Roach No. 2, being located 1980 feet from the west line and 1045 feet from the north line of Section 9, Township 29 N, Range 26 E, NMPM, Colfax County, New Mexico.

3. That said well was drilled to a total depth of 3485 feet, and that casing has been set and cemented as follows: 9-5/8" O.D., 32.30# N-40, S.T.&C., R-3 @ 727' w/350sx, 7" O.D., 20.00#, K-55 S.T.&C., R-3 @ 1,919' w/150sx, 5" o.d., 13.00#, K-55, S.T.&C., R-3 @ 1,775' - 2,174' w/60sx.

4. That operator and landowners have made an agreement whereby operator is to plug said well back to a plugged-back total depth of 1680 feet and transfer said well to landowners for their use as a water-well. Operator will leave casing in the well as is.

5. That when operator has complied with the provisions of Paragraph 4 above it will so notify the Oil Conservation Division of the State of New Mexico on Division Form C-103, together with a signed statement from the landowners that the provisions of Paragraph 4 above have been complied with to their satisfaction.
