1. Remove surface equipment. Pull tubing. Fill with water.
2. Clean out to 1500'. Place 50 sks (220') plug from 72" below to 150' inside casing w/class A @ 15.6 ppg. Fill to surface w/9.0 ppg gel mud.
3. Tagged top of plug @ 1252' (88' inside casing).
4. Place 13 sks (50') surface plug w/class A @ 15.6 ppg.
5. Place well marker, remove junk and debris from location.
6. All work completed 9/09/01.
7. Pipe left in well: 276' of 10 3/4" set @ 276' and 1340' of 7 5/8" set @ 1340'.
