1. Drilled to 1355'. Encountered too much water to drill with air.
2. Set 7 5/8", 26.4 #/ft. and 29.7 #/ft., K55 and N80 casing @ 1355' and cemented with 375 SX "H" + 2% CaCl<sub>2</sub> + 2% gel + 0.4% Halad 4 + 1/4 #/sack flocele + 5 #/sack gilsunite + 5% KCL. Had good cement returns to surface.
3. Tested casing to 700 PSI.
