4/16/90. Well had 1000 psi surface pressure, blow down in 5 minutes, no flow. Fill well bore with 8.6 ppg Bentonite gel mud. Set wireline bridge plug @ 3180 and pressure test O.K. Freepoint 2 7/8, pipe free @ 90'. Attempt to work pipe free at a deeper point. Cut 2 7/8 at 700' and 400' could not pull or circulate. 2 7/8 free @ 90'. Back off @ 83' and pull. Cement on bottom 40' of 2 7/8. Set 50' plug 83' to 33' with 4 sks class A @ 15.6 ppg. Cement fell to 70'. Back off 4 1/2 @ 70'. Set cement plug 70' to surface with 25 sks class A @ 16.5 ppg. Cut casing 3' below surface and set marker. Location cleared and leveled, pits filled
