4/14/90 Pull casing. Set 120' plug 1270 to 1150 with 36 sks class A cement @ 15.6 ppg. Set 150' casing seat plug 350 to 200 with 40 sks class A cement @ 15.6 ppg. Set 50' surface plug with 15 sks class A cement @ 15.6 ppg. Cut casing 3' below grade and set marker. Location cleared and leveled, pits filled.
