6/11/89 Drill 11" hole to 333'. Set and cement 12 jts (327.75') 8 5/8", 24 lb. J-55 ST&C casing w/170 sks class G w/2% CaCl @ 15.8 ppg. Bumped plug w/500 psi. Cement to surface.

8/21/89 Test casing & BOP w/600 psi for 30 mins. No pressure drop.

8/29/89 Drill 7 7/8" hole to 2588'. Logging.

8/30/89 Set and cement 96 jts (2546') 5 1/2", 17 lb. J-55, LT&C casing w/675 sks silicalite @ 11 ppg. Plug down w/1000 psi. Waiting on completion equipment.
