3/17/00 Run 8-5/8" Casing to 340'. Cement with BJ Services. Pump 100 sx. Type III + adds. 8 bbls cement to surface. WOC 8 hrs. Cement not hard. Displace hole with good cement. WOC 6 hrs.

3/18/00 WOC 2 hrs. Drill 7-7/8" hole to TD @ 2060'.

3/19/00 Log Wellbore. Run 5-1/2" casing to 2049'. Mix and Pump 270 sx. Type III + adds. Well bridged off 12 bbls into displacement. Will have to drill out cement to determine cement top and remedial action.
