02/02/01: Spud @ 11:00 AM, 02/01/01. Drill 11" surface hole to 340'. Run 14 jts. of 8-5/8" 23 ppf to 331'. Halliburton mixed and pumped 100 sx 14 lb/gal Midcon II PP with 6% salt, 5#/sx gilsonite & 0.3% versaset. Circulate 8 bbls cement to surface. WOC 8 hrs. Test surface csg to 500 psi for 30 minutes.

02/03/01: Drill 7 7/8" hole from 340' to 2485'. RU Schlumberger & log.

02/02/01: MIRU Leed. Run 61 jts. of 5 1/2", 15.5 ppf to 2413'. MIRU Halliburton. Mix and pump 20 bbl gelled water with 5 lb/bbl BaraCarb, 5 lb/bbl Magma Fiber followed by 346 sx 12.5 lb/gal Midcon II PP, 6% salt, 2 lb/sx Granulite TR 1/4, 5 lb/sx Gilsonite, 0.3% Versaset & 0.3% Super CBL. Plug down @ 1:02 PM 02/03/01 with 1375 psi. Circulated 20 bbls cement to surface.

03/06/01 MIRU Patterson Wireline. Ran Sector Bond Log from surface to 2485'. Estimated cement top at 45'.
