01/12/01: Spud @ 1:00 P.M., 01/11/01. Drill 11" surface hole to 330'. Run 16 jts. of 8-5/8 23# to 323'. Halliburton mixed and pumped 100 sx 14 lb/gal Midcon II PP with 6% salt, 5#/sx gilsonite & 0.3% versaset. Circulate 8 bbls cement to surface. WOC 8 hrs. Test surf. Csg to 500 psi for 30 minutes.

01/13/01: Drill 7 7/8" hole to TD @ 2105'. Rig up Schlumberger & log.

01/14/01: MIRU Leed. Run 55 jts of 5 1/2", 15.50 # to 2105'. MIRU Halliburton. Pump 20 bbls gelled water plus nitrogen and foamer followed by foamed cement containing 147 sx Midcon II PP, 6% salt, 0.3% versaset & 5#/sx gilsonite plus Nitrogen & foamer. Plug down @ 10:02 AM 01/13/01 w/800 psi. Circulated 10 bbls cement to surface.

01/16/01: MIRU Patterson Wireline. Ran Sector Bond Log from surface to 2048'. Top of Cement @ 210'
