03/19/01: Spud @ 1:45 AM. 03/19/01. Drill 11" surface hole to 330'. Run 15 jts. of 8-5/8" 23 ppf to 303'. Halliburton mixed and pumped 100 sx 14 lb/gal Midcon II PP with 6% salt, 5#/sx gilsonite & 0.3% versaset. Circulate 6.5 bbls cement to surface. WOC 8.5 hrs. Test surface csg to 500 psi for 30 minutes. Drill 7 7/8" hole from 330'-500'.

03/20/01: Drill 7 7/8" hole from 500'-2307'. RU Schlumberger & log.

03/21/01: MIRU Leed. Run 54 jts. of 5 1/2", 15.5 ppf to 2249'. MIRU Halliburton. Mix and pump 10 bbl gelled water with 5 lb/bbl BaraCarb, 5 lb/bbl Magma Fiber followed by 340 sx 13 lb/gal Midcon II PP, 6% salt, 2 lb/sx Granulite TR 1/4, 5 lb/sx Gilsonite, 0.3% Versaset & 0.3% Super CBL. Plug down @ 3:59 PM 03/21/01 with 1500 psi. Circulated 53 bbls cement to surface.
