04/01/01: Spud @ 9:55 AM. 04/01/01. Drill 11" surface hole to 330'. Run 15 jts. of 8-5/8" 23 ppf to 306'. Halliburton mixed and pumped 100 sx 14 lb/gal Midcon II PP with 6% salt, 5#/sx gilsonite & 0.3% versaset. Circulate 6 bbls cement to surface. WOC 8 hrs. Test surface csg to 500 psi for 30 minutes. Drill 7 7/8" hole from 330'-500'.

04/02/01: Drill 7 7/8" hole from 500'-2221'. RU Schlumberger & log. MIRU Leed. Run 52 jts. of 5 1/2", 15.5 ppf to 2194'.

04/03/01: MIRU Halliburton. Mix and pump 20 bbl gelled water with 5 lb/bbl BaraCarb, 5 lb/bbl Magma Fiber followed by 336 sx 12.5 lb/gal Midcon II PP, 6% salt, 2 lb/sx Granulite TR 1/4, 5 lb/sx Gilsonite, 0.3% Versaset & 0.3% Super CBL. Well bridged off while pumping cement requiring 1500 psi to break free. Plug down @ 6:59 AM 04/03/01 with 1325 psi. No cement circulated to surface.


