The well was T.D.'d at 7215' on 03-16-02. Casing was run immediately to avoid further drilling difficulties. On 03-25-02, Schlumberger ran a cased hole neutron log which determined the target zones, Entrada and Glorieta were considerably deeper.

This "Notice of Intent" is a request to Change Plans to deepen the well to +/- 7600' to ensure penetration to bottom of the Glorieta formation.
