02/10/02 Spud @ 4:05 p.m. Drill 11" surface hole to 320'.  
Run 10 jts. of 8-5/8" 23 ppf to 301'. Halliburton mixed and pumped 90 sx Midcon II PP, 14.0 ppg, with 6% salt, 5#/sx gilsonite & 0.3% versaset at 3 bpm with 25 psi. No cement to surface. WOC 2 hrs. Mixed and pumped 43 sxs Midcon II, 14.0 ppg, with 2 sx cedar fiber and 2 sx flocl. Circulated 1 bbl of cement on top off.

02/11/02 WOC 8 hrs. Test surface casing to 500 psi for 30 minutes.  
Drill 7 7/8" hole from 320'-2115'. Reached TD at 7:30 p.m.  
Schlumberger logged well. Ran 65 jts of 5 1/2", 15.5#, M-50 LT & C casing. Set casing at 2110'.

02/12/02 Halliburton mixed and pump 20 bbl gel pre flush at 3 bpm with 30 psi, 5 gal LGC-8, 120# magmafiber, 100 # baracarb with 5 bbl water spacer. Pumped 260 sx Midcon II, 13 ppg, yield 2.04 at 3 bpm with 30 psi, 6% salt, 2 lb/sx Granulite, 5 lb/sx Gilsonite, .3% Versaset, and .3% Super CBL. Plug down @ 6:01 a.m. with 710 psi. Circulated 12 bbls of cement to surface. Well shut in.
