Halliburton mixed and pumped 85 sks Midcon II PP, 14 ppg, yield 1.66 at 3 bpm with 25 psi with 6% salt, 5#/sx gilsonite, .3% versaset. Circulated 2 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 min.

04/19/02 Drill 7 7/8" hole @ 330' - 2065'. Reached TD 2065'. MIRU Schlumberger & log well. Ran 54 jts of 5 1/2", M-50, 15.5 ppf LT &C casing to 2039'. Halliburton mixed and pump 20 bbls gel pre flush at 4 bpm at 12 psi, 268 sks Midcon II, 13.0 ppg, yield 2.04, with 6% salt, .3% versaset, 5#/sx gilsonite, and .3% Super CBL. Plug down @ 1:16 p.m. with 1650 psi. Circulated 9 bbls of cement to surface. Well shut in.
