

Halliburton mixed and pumped 85 sks Midcon II PP, 14 ppg, yield 1.66 at 3 bpm with 60 psi with 6% salt, 5#/sx gilsonite, .3% versaset. Circulated 2 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 min.

04/18/02 Drill 7 7/8" hole f/ 335' - 2325'. Reached TD 2325'. MIRU Schlumberger & log well. Ran 62 jts of 5 1/2", M-50, 15.5 ppf LT & C casing to 2302'. Halliburton mixed and pump 20 bbls gel pre flush at 4 bpm at 15 psi, 325 sks Midcon II, 13.0 ppg, yield 2.04, with 6% salt, .3% versaset, 5#/sx gilsonite, and .3% Super CBL.
