02/02/03 Spud in @ 3:00 p.m. Drill 11" surface hole to 335'. Ran 11 jts of 8 5/8", J-55, 23 ppf ST&C casing to 324'. Halliburton mixed and pumped 100 sks Midcon II PP, 14 ppg, yield 1.66 at 3 bpm with 40 psi with 6% salt, 5#/sx gilsonite, .2% versaset, and .25 #/sk floccle. Circulated 7 bbls of cement to surface. WGC 8 hrs. Test surface casing to 500 psi for 30 min.

02/03/03 Drill 7 7/8" hole @ 335' - 2236'. Reached TD 2236'. MURU Schlumberger & log well. Ran 12 jts of 5 1/2", #17, J-55 and 41 jts of 5 1/2", #15.5, J-55, LT & C casing to 2198'. Halliburton mixed and pump 40 bbls gel pre flush at 3 bpm at 0 psi, 302 sks Midcon II, 13.0 ppg, yield 2.04, with 6% salt, .3% versaset, 5#/sx gilsonite, .2% versaset, .1% super CBL and .25 #/sk floccle. Plug down @ 4:42 p.m. with 1450 psi. Circulated 22 bbls of cement to surface. Well shut in.
