01/12/03 Spud in @ 2:00 p.m. Drill 11" surface hole to 330'. Ran 10 jts of 8 5/8", J-55, 24 ppf ST&C casing to 322'. Halliburton mixed and pumped 100 sks Midcon II PP, 14 ppg, yield 1.66 at 3 bpm with 6% salt, .3% gilsonite, .3% versaset, and 25# flocele per sack. Circulated 8 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 min.

01/13/03 Drill 7 7/8" hole f/ 330' - 1765'. Reached TD 1765'. MIRU Schlumberger & log well. Ran 12 jts of 5 1/2", J-55, and 29 jts of 5 1/2", M-50, 15.5 ppf LT & C casing to 1741'. Halliburton mixed and pump 20 bbls gel pre flush at 4 bpm at 35 psi, 239 sks Midcon II, 13.0 ppg, yield 2.04, .3% versaset, 5#/sx gilsonite, 2#/sk granulate, 6% salt and .1% Super CBL. Plug down @ 2:36 a.m. on 01-14-03. Circulated 25 bbls of cement to surface. Well shut in.
