Spudded 11" hole at 2:00 PM 7/2/80 (TD 25'). Ran 25' of 8 5/8" 32# J-55 casing and cemented with 8 sacks of neat cement containing 2% calcium chloride from TD to surface. Drilled well to 445' TD with a 7 7/8" bit. Well shut in 7/9/80 and is being held for possible enhanced recovery.

Cored well as follows: 272' - 297', 297' - 322', 322' - 347', 347' - 372' and 372' - 395.75'.
