Re: Operations Summary and Proposal

O'Connell Ranch Unit T-4 Enhanced Recovery Unit Guadalupe County, NM

Gentlemen:

In response to your recent request, DCR Petroleum Corporation would like to submit to you, copies of approved C-104 Forms and copies of C-115 Forms for the period of their operations from March, 1985, thru the present. Also, there is an attached chronological summary of operations carried out by DCR Petroleum from initial acquisition of these properties thru the present.

DCR Petroleum Corporation plans to initiate a pilot EOR steamflood project for both the O'Connell Ranch and T-4 Ranch Units approximately late in 1988 or early, 1989. This is a delay from previous plans due to the large change in oil production economics during the past two years since DCR Petroleum acquired these properties. With industry economics continuing to fluctuate, it is difficult to establish and budget for an exact initiation date for a pilot EOR project to begin. To improve this situation, it is being considered to install a cogeneration facility in conjunction with the EOR project which may sufficiently enhance economics and justify capital investments at todays oil price. Discussions are under way with potential industry partners to assess the viability of this approach for project development.

Clean out fill and run and install new pump. Put well back on production. Well #11: Pulled rods and pump. Replace pump. Put well on production. Pull well again and fill with water.
