Spudded 11" hole at 1:00 PM August 30, 1980 (TD 22'). Ran 22' of 8 5/8" 23# J-55 casing and cemented with 7 sacks of neat cement containing 2% calcium chloride from TD to surface. Drilled well to 500' TD with 7 7/8" bit. Shut in well and holding for possible enhanced recovery flood.

Cored well as follows: 338' - 365'; 365' - 392'; 392' - 419'; 419' - 444' and 444' - 460'.
