17. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Spudded 11" hole at 2:15 PM on 2-24-81 (TD 30'). Ran 30' of 8 5/8" 20# casing and cemented with 12 sacks of neat cement from TD to surface. Drilled 7 7/8" hole to 510' TD. Ran 515' of 4 1/2" 11.6# K-55 casing and cemented as follows: Pumped 40 bbls. of 5% KCl gelled water containing 2 eals. of Marflo. Pumped 120 sacks of Class "H" cement containing 0.5% Halad-9 and followed with 120 sacks of Class "H" cement containing 2% calcium chloride. Circulated out 84 sacks of cement. Centralizers installed at 416', 458' and 499'. Pressure tested casing to 600 psig for 30 minutes and casing held.

Cored well as follows: 395' - 421', 421' - 437', 437' - 474'.

NOTE: Public Lands Exploration Co., Inc. changed their name to Corona Oil Co.
