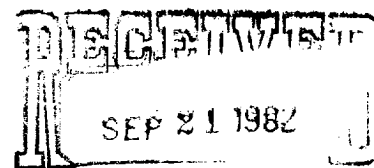

- 1) Rig up N. L. McCullough pulling unit. Set Cast Iron Bridge Plug at 2450', dumped 20' of cement on plug back to 2430'. Cut 4-1/2" casing at 1050'.
- 2) Spot 25 sack cement plug at 1050' back to 967'. Laid down 4-1/2" casing.
- 3) Cut 7" casing at 920'. Laid down 7" casing.
- 4) Spot 25 sack cement plug at 434' back to 340'. Spotted 5 sack cement plug from 30' to surface.
- 5) Laid down 2-3/8" tubing. Capped well in and set NMOCC Well Marker and moved off location.
