8/13/84: Drill out D.V. Tool. Circulate hole with 2% KCL.
8/14/84: Ran cement bond log. Perf 5573'-5576', 8 holes. Broke down 1500 psi.
8/15/84: Acidized with Halliburton 1000 gals. 15% MCA acid. Swab back load (No gas or oil.)
8/16/84: Set CIBP at 5555' and tested 2000 psi. Perf at 5528'-5530, 6 holes. Broke formation at 1900 psi. Swabbed well dry.
8/17/84: Acidized with 750 gals. 10% Morrow Flow BC & 1000 SCF/bbl nitrogen.
8/20/84: Flowed and swabbed back load. (No gas or oil.)
8/21/84: Set CIBP at 5510'. Perf 5477'-5482', 12 holes. Swabbed zone, no show.
8/22/84: Acidized zone with 400 gals. 10% MSA-acid. Broke down at 2000 psi. Swab back load (show of gas) would not flow.
8/23/84: Acidized zone with 1500 gal. 15% MSA/1000 SCF/bbl N₂. Flowed and swabbed well.
8/24/84: Flowed well down slight show of gas.
8/26/84: Swabbing well.
8/27/84: Frac zone with 15000 gal pure gel & 20% CO₂. Average rate 12 bbls/min.
8/28/84: Flowing frac load back. Swabbing well until 8/31/84.
8/31/84: Frac zone 14000 gals pure gel & 67 tons CO₂, 15000# 20/40 sand, 8000# 20/40 Interprops. Flowing loads back.
9/1/84 - 9/9/84: Swabbing load back. Slight show of gas.
9/9/84: Ran BHP bomb. 2127 psi after 72 hours.

9/11/84: Set CIBP at 5450'. Perf 5394'-5396', 8 holes. Acidized with 500 gal 7-1/2 NEFE acid.

9/12/84: Swab back load (show of gas). Swabbing gas and formation H₂O.

9/14/84: Run RBP to 5280'. Perf 5260'-5268', 18 holes. Acidized with 2000 gal 7-1/2% NEFE acid.

9/17/84: Set CIBP at 5350'. Dumped 20' of cement on top.

9/19/84: Frac well using 16000 gal pure gel 40, 8000 gal CO₂, 15000# 20/40 sand, 6000# 20/40 interprops.

9/20/84: Flowing good gas but making lots of salt water. Swab well. Still good show of gas.

10/11/84: Tubing psi - 1600. Casing psi - 1500 psi.

10/19/84: Set CIBP at 5020'. Perf 4558'-4635', 19 holes. Acidize zone with 3000 gal 10% NEFE acid.

10/20/84 - 10/23/84: Swabbed on well. No show of gas.

10/24/84: Shut in well, waiting on further completion.
