I2-31-54: Spudded-Drilled 11" hole to 256'. Reamed to 17 1/2" to 215'.

I-3-55: Ran 6 Jts. 13 5/8" O.D. 36# Armco Spiral Casing. Set at 215' R.D.B. Cemented by Halliburton with 200 sac Reg. Cement, 190# Calcium Chloride. Cement circulated 30' left in pipe. Cement set 24 hours.

I-4-55: Close B.C.P. and pressure to 400 P.S.I. for 30 minutes. Holding-To drill ahead.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
