He will try to get well for water supply.

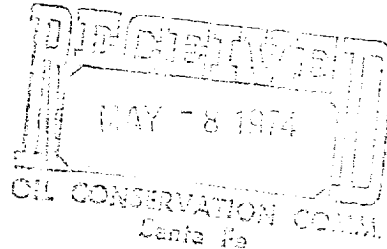

Dear Mr. Hankins:

Attached is page D-2 of the O.C.C. regulations. You will note Rule 203 is only provision for handling a well other than completing as an oil/gas producer or plugging. If conversion is made to a water well, it will be necessary to follow this rule. Copies (to be filed in triplicate) of a form to facilitate the transfer of responsibility for such a well are enclosed for your convenience.

Please note also parts (b) and (c) of Rule 202.
