Dear Sir:

On November 1, 1974, I wrote you concerning carbon dioxide wells in the Bueyeros Field and in the South Bueyeros area. To date, no reply has been received. Consequently the Commission files continue to present a confusing and probably an erroneous description of actual conditions.

As mentioned by that letter, it is imperative that Commission records be correct, and to accomplish such a correction, a field investigation has been initiated. During inspections of wells located in Township 21 North, Range 30 East, Harding County, several landowners advised that some of the wells in this township were produced about two years ago. (Several of these locations were described by the November 1, 1974 letter). The Oil Conservation Commission has no record of production from this township since October 1971, at which time Adams submitted reports crediting production to Units 8214 and 8250.

Your production report (C-111) for February, 1973, carries the notation "Schwartz Carbonic Company does not lease the Adams Plant anymore." Could you advise the date on which production from Township 21 North, Range 30 East, was suspended? Did your lease include all of the Adams & McGahey wells?

Any information you can provide relative to Townships 20 and 21 North, Range 30 East, will be appreciated.
