Enclosed, per your request of July 25, 1974, are copies of various reports for the following wells:

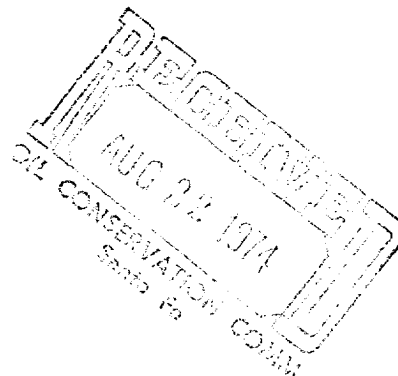
