Propose to cement behind 4-1/2" production casing per the following procedure:

Kill well. Pull tubing and packer. Set a retrievable bridge plug at 2200' and cap with sand. Run pipe recovery log to determine top of cement. Perforate 20' above top of cement. Set packer 300' above perms. Establish circulation. Pump 16 bbl. colored dye. Pump sufficient Class C cement to circulate. WOC. Pull tubing, packer, and bridge plug. Run tubing and packer.
