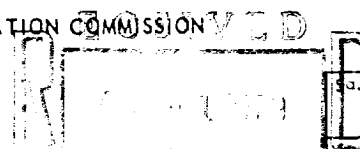

On 7-11-79 Baker & Taylor #16 spudded a 12-1/4" hole at 12:45 PM. Drilled to a TD of 360' and ran 8-5/8" 24# casing set a 356'. Cemented with 200 sx Class C Vicor cement with 2% CACL. Plugdown 4:30 AM 7-12-79. Circulated 20sx. WOC 19 hrs. Tested casing with 1000# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling.
