Propose to cement behind 4-1/2" production casing per the following:

Kill well. Pull tubing. Set a retrievable bridge plug at 2100' and cap with 10' sand. Run pipe recovery log to determine cement top. Top estimated to be at 1500'. Perforate 20' above top of cement. Set packer 300' above perfs. Establish circulation. Pump 16 bbl. colored dye. Pump sufficient cement to circulate. WOC. Pull packer and bridge plug. Run tubing.
